## **RESOLUTION No. 21-256**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY SOUND LAB FLORIDA LLC, TO HOST THE "BOLIVAR PHIL AND FRIENDS SYMPHONIC CONCERT" AT DOWNTOWN DORAL PARK, LOCATED AT 8395 NW 53 STREET, DORAL, FL, ON SATURDAY, FEBRUARY 12, 2022, FROM 8:00 P.M. TO 11:00 P.M.; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Omar Calderon on behalf of Sound Lab Florida LLC (the "Applicant") seeks approval from the City of Doral of a special event permit to host the "Bolivar Phil & Friends" symphonic concert; and

WHEREAS, staff recommends that the Mayor & City Council approve the proposed special event permit to host the "Bolivar Phil Friends" event Saturday, February 12, 2022 at Downtown Doral Park, located 8395 NW 53 Street, Doral, FL, from 8:00 p.m. to 11:00 p.m.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

**Section 1. Recitals.** The above recitals are true and correct and incorporated herein.

**Section 2**. **Approval**. The special event permit for the "Bolivar Phil & Friends" symphonic concert is hereby approved subject to the following conditions:

- 1. The applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.
- 2. Applicant shall be required to have all inspections and approvals prior to the event date.

- Sanitary facilities shall be provided by the applicant and shall be of the type and in a sufficient number as to meet the requirements established by the building department.
- 4. The applicant is responsible for providing adequate security at the outdoor event. The police department may require the applicant to provide and pay for security personnel for crowd control and traffic direction purposes. The county fire rescue department may require the applicant to provide and pay for fire watch personnel.
- 5. Applicant shall comply with comments made by the City of Doral Police Department and pay all applicable fees no later than 14 days in advance of the event.
- Applicant shall comply with comments made by the City of Doral Parks and Recreation Department and pay all applicable fees no later than 14 days in advance of the event.
- 7. Applicant shall provide to the City of Doral proof of all required licenses and an acceptable certificate of insurance four weeks prior to the event date.

<u>Section 3.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
