A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING A WORK ORDER BETWEEN THE CITY OF DORAL AND A&P CONSULTING TRANSPORTATION ENGINEERS FOR THE PROVISION OF CONSTRUCTION ENGINEERING INSPECTION SERVICES FOR THE CONSTRUCTION OF NW 97 AVENUE FROM NW 70 STREET TO NW 74 STREET, IN AN AMOUNT NOT TO EXCEED \$78,178.18; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in February of 2014, the City of Doral (City) Public Works Department (PWD) issued a Work Order for A&P Consulting Transportation Engineers (A&P) to develop construction plans for NW 97 Avenue from NW 70 Street to NW 74 Street; and

WHEREAS, in February of 2014, the City entered into a Joint Participation Agreement with Miami-Dade County for the City to proceed with the construction of NW 97 Avenue from NW 70 Street to NW 74 Street (Project) and the reimbursement of the construction cost to the City; and

WHEREAS, the PWD desires to secure a firm to provide Construction Engineering Inspection (CEI) services for Project; and

WHEREAS, A&P is a prequalified provider of professional services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in September 2011. Following a review of the experience and qualifications for the pool of prequalified firms, it was determined that A&P has the most relevant experience to provide CEI services for the Project; and

WHEREAS, Staff respectfully requests that the City Council approve the Work Order with A&P to provide CEI services for the Project in an amount not to exceed \$78,178.18.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Approval. The Work Order between the City of Doral and A&P Consulting Transportation Engineers for CEI services for the construction of NW 97 Avenue from NW 70 Street to NW 74 Street; in an amount not to exceed \$78,178.18, a copy which is attached hereto as Exhibit "A", is hereby approved. The City Manager is authorized to execute the Work Order and expend budgeted funds on behalf of the City.

<u>Section 3.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.

I. GENERAL

 - c. Oversight of the type B stabilization process including the required testing and sampling by contractor.
 - d. Oversight of the construction of the base including the required testing and sampling by contractor.
- D. Task 4- Monitor New Curb and Gutter construction.
- E. Task 5- Monitor New Sidewalk construction by Contractor.
- F. Task 6- Monitor Minor Milling and Resurfacing by Contractor.
