

RESOLUTION No. 21-228

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY LIBERATION EVENT MANAGEMENT, LLC TO HOST THE GOOD LIBATIONS EVENT AT DOWNTOWN DORAL PARK, LOCATED AT 8395 NW 53 STREET, DORAL, FL 33166 ON SATURDAY, JANUARY 15, 2022 AND SUNDAY, JANUARY 16, 2022, FROM 12:00 PM TO 6:00 PM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Matthew Fillioe on behalf of Liberation Event Management, LLC (the “Applicant”) seeks approval from the City of Doral for a Special Event Permit to host the “Good Libations” event; and

WHEREAS, staff recommends that the Mayor & City Council approve the proposed Special Event Permit to host the “Good Libations” event Saturday, January 15, 2022 and Sunday, January 16, 2022 at Downtown Doral Park, located at 8395 NW 53 Street, Doral, FL 33166, from 12:00 p.m. to 6:00 p.m.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Approval. The special event permit for the “Good Libations” is hereby approved subject to the following conditions:

1. Applicant shall comply with comments made by the City of Doral Police and Parks Departments and pay all applicable fees.
2. Applicant shall obtain all required permits and licenses.
3. Applicant shall be required to have all inspections and approvals prior to the event date.

4. Applicant shall provide to the City of Doral with an acceptable certificate of insurance four weeks prior to the event date.

Section 3. Effective Date. This Resolution shall take effect immediately upon adoption.
