A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO ENTER INTO A LICENSE AGREEMENT WITH THE MIAMI-DADE EXPRESSWAY AUTHORITY (MDX) IN ORDER FOR THE DORAL TROLLEY SYSTEM TO SERVICE THE DOLPHIN STATION PARK-AND-RIDE LOT AT NO COST TO THE CITY; THE CITY MANAGER TO EXECUTE AUTHORIZING THE AGREEMENT: PROVIDING **FOR** IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in order to keep up with trolley passenger demands and better serve the community, the Public Works Department (PWD) continually reviews the Doral Trolley System to recommend improvements; and

WHEREAS, in September of 2017, City Council authorized the implementation of improvements to Trolley Route 1, 2, and 3, and in November 2017, the City Council approved the implementation of the new Florida International University (FIU) Trolley Route (Route 4); and

WHEREAS, on August 20, 2018, the PWD initiated the improvements to Routes 1, 2, and 3 as well as commenced Route 4; and

WHEREAS, in addition to the previously approved expansion of Route 1 to service the Dolphin Mall and Doral Legacy Park, the PWD has been coordinating with the Miami-Dade Expressway Authority (MDX) and the Miami-Dade County Department of Transportation and Public Works (DTPW) to extend Route 1 to service the new Dolphin Station Park-and-Ride Lot; and

WHEREAS, the PWD is developing the revised schedule for Route 1 based on the modified trolley alignment which will service the Dolphin Station Park-and-Ride Lot; and

WHEREAS, the PWD respectfully requests authorization from City Council for the City Manager to enter into a License Agreement with the Miami-Dade Expressway Authority (MDX) in order for the Doral Trolley System to service the Dolphin Station Park-and-Ride Lot at a no cost to the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

<u>Section 2.</u> Approval. The License Agreement with the Miami-Dade Expressway Authority in order for the Doral Trolley System to service the Dolphin Station Park-and-Ride Lot at a no cost to the City is hereby approved.

<u>Section 3.</u> <u>Authorization.</u> The City Manager is authorized to execute the License Agreement with the Miami-Dade Expressway Authority in order for the Doral Trolley System to service the Dolphin Station Park-and-Ride Lot at a no cost to the City.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and City Attorney are hereby authorized to take such action as may be necessary to implement the purpose and the provisions of this resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
