

**RESOLUTION No. 21-91**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE APPLICATION TO THE EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT- DIRECT (JAGD) PROGRAM FOR GRANT FUNDS IN THE AMOUNT OF \$10,000.00 (REIMBURSABLE); AUTHORIZING THE CITY MANAGER TO EXPEND FUNDS IN THE AMOUNT NOT TO EXCEED \$10,000.00, FOR THE PURCHASE OF FIVE (5) WIRELESS MOBILE RADIO UNITS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral Police Department has been awarded \$10,000.00 from the Edward Byrne Justice Assistance Grant-Direct (JAGD) Program as a reimbursable grant and expend funds from the Department of Justice—Byrne Grant Capital Outlay account (001.60005.500642) in an amount not to exceed \$10,000.00, which will be used to purchase five (5) wireless mobile radio units from PVP Communications, Inc., to provide the motormen the ability to communicate clearly and safely, while operating their motorcycles; and

**WHEREAS**, Staff respectfully requests that the Mayor and City Council authorize the application to the JAGD Program for grant funds in the amount of \$10,000.00 as a reimbursable grant and expend funds from the Department of Justice-Byrne Grant Capital Outlay account (001.60005.500642) in an amount not to exceed \$10,000.00 to purchase five (5) wireless mobile radio units to provide the motormen the ability to communicate clearly and safely, while operating their motorcycles;

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** The City Manager hereby authorizes the application to the JAGD Program for grant funds account 001.6000.334200 in the amount of \$10,000.00 reimbursable grant and expend funds from Department of Justice-Byrne Grant Capital Outlay account 001.60005.500642 in the amount of \$10,000.00 to purchase five (5) wireless mobile radio units from PVP Communications, Inc. as they are a sole source manufacturer.

**Section 3. Authorization:** The City Manager is hereby authorized to execute the application and expend funds (reimbursable) on behalf of the City.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall become effective immediately upon its adoption.
