

**RESOLUTION No. 17-168**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES, APPROVING THE PURCHASE OF CERTAIN EQUIPMENT FROM THE FEDERAL BUREAU OF INVESTIGATION, IN AN AMOUNT NOT TO EXCEED \$54,245.00; AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT, SUBJECT TO APPROVAL BY THE CITY ATTORNEY AS TO FORM AND LEGAL SUFFICIENCY, AND TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Police Department for the City of Doral (the "City") seeks to purchase certain equipment from the Federal Bureau of Investigation (the "FBI") to be utilized by City of Doral Detective and FBI agents; and

**WHEREAS**, the Doral Police Department is seeking approval to purchase equipment to be utilized by City of Doral detectives and FBI agents. The FBI has agreed to equip the Criminal Investigation Section with a variety of equipment such as, interview room with high tech voice and video system to be used during interviews and interrogations, one currency counter for the property room, concealable video and voice recorders to be used in proactive investigations, a DIVRT System to analyze any video during investigations, and Cellebrite units to download phone data. Additional equipment will be purchased to be utilized by FBI agents and Doral detectives; and

**WHEREAS**, this agreement with the FBI who will use Joint Law Enforcement Operations funding provided by the Department of Justice's Assets Forfeiture Fund will reimburse the City of Doral for this Fiscal Year 2017 equipment purchase. The FBI will reimburse the City of Doral within 30 to 60 days from purchased date. The Police Department analyzed its current funding for FY 2017-2018 and seeks to purchase all of

the equipment from available funding thru the LETF-Justice Account 105.60005.500640.

The cost of all the equipment will not exceed \$54,245.00.

**WHEREAS**, Staff further requests that the City Council authorize the City Manager and the City Attorney to negotiate and enter into an agreement with the FBI.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** Pursuant to section 2-322 of the City Code of Ordinance, the City Manager is hereby authorizes the purchase of FBI Equipment in an amount not to exceed \$54,245.00. This purchase is funded in account 105.60005.500640 LETF- Justice.

**Section 3. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 4. Effective Date.** This Resolution shall become effective immediately upon its adoption.

The foregoing Resolution was offered by Councilmember Rodriguez who moved its adoption. The motion was seconded by Vice Mayor Cabrera and upon being put to a vote, the vote was as follows:
