A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA WAIVING THE COMPETITIVE BIDDING PROCESS AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH AECOM FOR THE PROVISION OF DESIGN AND CONSTRUCTION ADMINISTRATIVE SERVICES FOR THE CITY OF DORAL DOG PARK IN AN AMOUNT NOT TO EXCEED \$90,000.00; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral has nearly completed the engineering for the proposed Dog Park and is now in need for professional design services for the Dog Park property; and

WHEREAS, the team from AECOM has been working on the Park system Master

Plan for the City and has a clear understanding of the residents' needs; and

WHEREAS, it is in the best interest of the City to continue to obtain these services from AECOM due to the uniqueness of AECOM's current working relationship with the City; and

WHEREAS, pursuant to City of Doral Ordinance #2004-03, Staff respectfully requests that the City Council waive the competitive bidding process and authorize the City Manager to negotiate and enter into an agreement with AECOM for the provision of design and construction administrative services for the City of Doral Dog Park in an amount not to exceed \$90,000.00.
