WHEREAS, the City Council finds it to be mutually beneficial for the City to donate the above vehicles to the City of Opa-Locka;

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. The sale of twelve (12) 2008 Crown Victoria surplus police vehicles from the City of Doral to the City of Opa-Locka, for nominal value, pursuant to the "Bill of Sale," which is attached hereto and incorporated herein as Exhibit "A".

Section 3. Authorization. The City Manager is hereby authorized to execute the Bill of Sale and such other contractual documents as may be necessary to effectuate the transfer of the Vehicles as contemplated herein.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.

WHEREAS, Opa Locka has voiced its interest in acquiring the vehicles for use by its police department; now, therefore

IN CONSIDERATION of the mutual covenants and conditions herein expressed and the faithful performance of all such covenants and conditions undersigned Doral and Opa Locka do mutually agree as follows:

- (1) Opa Locka agrees to pay Doral one dollar (\$1.00) for the purchase of the above listed vehicles from the City of Doral in "as is" condition.
- (2) Opa Locka acknowledges and accepts the vehicles in their present condition. ALL VEHICLES ARE SOLD AS IS. THE CITY OF DORAL MAKES NO EXPRESS OR IMPLIED WARRANTIES WHATSOEVER INCLUDING, BUT NOT LIMITED TO, THE EXCLUSION OF THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS.
- (3) Opa Locka agrees that the vehicles are being sold to Opa Locka in their present condition.
- (4) Opa Locka agrees to unconditionally release, waive, and discharge the City of Doral, its Commission members, employees, agents, and servants, all hereafter referred to as "releasees," from all claims and courses of action, that it, its Commission members, employees, agents and

servants may have for any loss, damage, or injury to person or property, whether caused by the negligence, or otherwise of the releasees. In addition, Opa Locka agrees to indemnify completely, the releasees against all claims, demands, and actions arising out of its actions or involvement with the use of the vehicles.

(5) Doral agrees to relinquish all rights to the vehicles.
