

**RESOLUTION No. 17-103**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE CITY'S INVOLVEMENT IN THE SUMMER FOOD SERVICE PROGRAM FOR A PERIOD OF FIVE (5) YEARS; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, on December 15, 2016, the City of Doral (the "City"), by and through the Parks and Recreation Department, applied for the Summer Food Service Program, a federally funded and state executed, nine-week food service program for children, with the City seeking assistance for the children attending the 2017 City Summer Camps held at Morgan Levy Park, Doral Meadow Park and Doral Legacy Park (the "SFSP"); and

**WHEREAS**, the SFSP is administered by the Village Youth Services, Inc., a non-profit responsible for overseeing delivery of food to the City's designated feeding site at Morgan Levy Park, Doral Meadow Park and Doral Legacy Park; and

**WHEREAS**, on April 26, 2017, the City was advised by Village Youth Services, Inc. that the City's application to participate in the SFSP had been approved, resulting in the provision of daily free lunches and snacks for approximately one hundred (100) children at Morgan Levy Park, approximately twenty (20) children at Doral Meadow Park and approximately one hundred and twenty (120) children at Doral Legacy Park; and

**WHEREAS**, participation in the SFSP has no direct cost to the City, except for the limited costs of personnel needed to implement, monitor and manage the City's involvement in the SFSP; and

**WHEREAS**, staff has recommended approval of the City's participation in the SFSP; and

**WHEREAS**, the Mayor and City Council desire for the City to participate in the SFSP

and to offer the families of children who participate in the City Summer Camps at Morgan Levy Park, Doral Meadow Park and Doral Legacy Park the opportunity to obtain a free, nutritious lunch for their children and to generally provide a new incentive to participating in the City Summer Camps.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** The City's involvement in the Summer Food Service Program, pursuant to the City's Applications, which is attached hereto as Exhibit "A", is approved for a period of five (5) years.

**Section 3. Implementation.** The City Manager is authorized to execute any documents related to the SFSP, to direct staff to assist in the implementation of the SFSP, and to take such other action, as may be necessary to accomplish the objectives of this Resolution.

**Section 4. Effective Date.** This resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Rodriguez who moved its adoption. The motion was seconded by Vice Mayor Cabrera and upon being put to a vote, the vote was as follows:
