RESOLUTION NO.14-132

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE USE OF THE EXISTING, COMPETITIVELY BID AGREEMENT BETWEEN THE STATE OF FLORIDA AND DON REID FORD, INC. FOR THE PROVISION OF TWO 2014 FOR ESCAPE (FWD 4DR SE) VEHICLES, INCLUDING LED CORNER STROBES FOR THE BUILDING DEPARTMENT IN AMOUNT NOT TO EXCEED \$42,437.10, PURSUANT TO SECTION 2-322 OF THE CITY OF DORAL CODE OF ORDINANCE; AUTHORIZING THE MANAGER TO EXECUTE CONTRACTUAL DOCUMENTS AND TO EXPEND BUDGET FUNDS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Building Department for the City of Doral (the "City") has a need to purchase additional vehicles for its fleet in order to meet increased inspection demands and provide transportation for newly hired Building Inspectors; and

WHEREAS, the State of Florida competitively bid, in a manner similar to that set forth in Article V of the City Code, the provision of fleet vehicle and awarded an agreement to Don Reid Ford, Inc., a copy of which is attached as Exhibit "A" ("State Contract"); and

WHEREAS, Staff has reviewed and analyze the State Contract and finds the provision of fleet vehicles and the corresponding prices to be highly competitive and advantageous to the City and recommends the City procure two (2) 2014 Ford Escape (FWD 4DR SE) vehicles, including corner LED strobe lights (the "Vehicles") pursuant to the State Contract; and

WHEREAS, it is essential to maintain a pool of spare vehicles to address unexpected repair needs and thus, this additional purchase will address that potential need; and

WHEREAS, the purchase of the Vehicles will allow the Building Department to maintain an appropriate number of vehicles in its fleet needed to meet demand, address

shortages caused by vehicle maintenance and repairs, and reduce inordinate delays in responding to customers; and

WHEREAS, the Building Department had previously budgeted for the purchase of two vehicles; and

WHEREAS, Section 2-322 of the City Code provides that the City may enter into entered into by other governmental authorities provided that the governmental authority has followed a competitive bidding procedure leading to the award of the bid or contract in question which is substantially similar to the competitive bidding procedure outlined in this article; and

WHEREAS, the Mayor and Council find that the purchase of the Copying Goods and Services pursuant to the competitively bid and advantageous MDCPS Contract is in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Procurement Approved. Pursuant to Section 2-322 of the City's Code of Ordinance, the procurement of two (2) Ford Escape (FWD 4DR SE) vehicles, including corner LED strobe lights, for the Building Department from Don Reid For, Inc. in a purchase price amount not to exceed \$42,437.10, via the State Contract, a copy of which is attached hereto as Exhibit "A" and incorporated herein by this reference, is hereby approved.

Section 3. Authorization. The City Manager is hereby authorized to execute any purchase orders, agreements or other documents, after approval as to form and legal sufficiency by the City Attorney, as may be needed to accomplish the contemplated purchase of the Vehicles and to expend budgeted funds on behalf of the City with respect to the purchase approved herein.

<u>Section 4.</u> <u>Effective Date.</u> This resolution shall take effect immediately upon adoption.

The foregoing resolution was offered by Councilmember Ruiz who moved its adoption.
