

RESOLUTION No.17-101

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES, APPROVING THE PURCHASE OF AN ANNUAL UPGRADE, RENEWALS, MAINTENANCE AND SUPPORT FOR VMWARE INC.'S SOFTWARE FROM V-CLOUD TECH, VIA STATE OF FLORIDA AGREEMENT PARTICIPATING ADDENDUM, VS6-OEPL-P-SSS-F IN AN AMOUNT NOT TO EXCEED ANNUAL BUDGETED FUNDS; AUTHORIZING THE CITY MANAGER TO EXECUTE AN ANNUAL UPGRADE, MAINTENANCE AND SUPPORT AGREEMENT AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City Council for the City of Doral (the "City") approved Resolutions 15-228 and 17-06 to purchase services from VMWare, for license, renewals, service and support of the existing software that operates our virtual environment; and

WHEREAS, VMWare is the existing software that operates our entire virtual environment throughout all City's facilities and the NAP location; and

WHEREAS, the Information Technology staff has reviewed the existing virtual infrastructure licenses and support needs in order to inventory our license and support renewal and bring them up to date plus expand functionality; and

WHEREAS, maintaining a current virtual software environment with the latest versions and software patches is critical to the City's infrastructure and helps align our systems with industry best practices; and

WHEREAS, upgrades to our virtual infrastructure and software that supports it is a key initiative outlined in our environment health checks performed by staff; and

WHEREAS, staff has recommended the Mayor and City Council approve the purchase VMWare Inc.'s software renewals, upgrades, service and support for the City's licenses using purchase of annual upgrade, renewals, maintenance and support for

VMWare Inc.'s Software from Vcloud Tech, via State of Florida agreement participating addendum, VS6-OEPL-P-SSS-F in an amount not to exceed annual budgeted funds

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. Pursuant to Section 2-322 of the City Code, the purchase of annual upgrade, renewals, maintenance and support for VMWare Inc.'s Software from Vcloud Tech, via State of Florida agreement participating addendum, VS6-OEPL-P-SSS-F in an amount not to exceed annual budgeted funds

Section 3. Authorization. The City Manager is hereby authorized to negotiate and facilitate the purchase contemplated herein. The City Manager is authorized to execute such agreements and other contractual documents, subject to approval by the City Attorney as to form and legal sufficiency, as may be necessary to consummate the procurement of the good and services contemplated herein. The City Manager is further authorized to expend budgeted funds in furtherance hereof.

Section 4. Implementation. The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.
