A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, APPOINTING ALEJANDRO MUJICA TO THE CITY OF DORAL PARKS & RECREATION ADVISORY BOARD; JENEISSAY AZCUY TO THE PARKS AND POLICE 4 KIDS ADVISORY BOARD; STEVE MUSOLINO, MELISSA TAPANES-LLAHUES AND BARBARA ROMANI TO THE DORAL DESIGN DISTRICT STEERING COMMITTEE, AND ERNESTO ANTON, ALFREDO LLOP, FRANK BOLANOS, HANI JARDACK, BENITO IRAZTORZA, VIOLA SANCHEZ AND JOY RUIZ TO THE BUILDING DEPARTMENT ADVISORY TASK FORCE; AND PROVIDING FOR AN EFFECTIVE DATE
