A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AMENDING THE CURRENT FIELD USAGE RATE FEE SCHEDULE TO INCLUDE THE DORAL BASED NON-PROFIT ORGANIZATION FIELD USAGE RATE; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, The City of Doral seeks to support residents by providing affordable field rentals for approved, Doral Based Non-Profit Organizations while preserving use for residents, youth sports providers and maintaining quality conditions; and

WHEREAS, Staff respectfully requests that Council amend the current field usage rate fee schedule to include the proposed Doral Based Non-Profit Organization field usage rate and all applicable conditions as described in Exhibit "A" herein.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

**Section 1.** The City Council of the City of Doral, Florida hereby amends the current field usage rate fee schedule to include the Doral Based Non-Profit Organization field usage rates and applicable conditions as described in Exhibit "A".

**Section 2**. This Resolution shall take effect immediately upon adoption.


Doral Based Non-Profit Organization Field Usage Rate

The Parks and Recreation Department respectfully requests consideration of the recommendation to amend the current fee schedule to include a special reduced rate for Doral Based Non-Profit Organizations. The proposed new rate along with the current resident rate is as follows:

In order to qualify for the reduced rate, interested organizations would be required to provide proof of a current not-for-profit status, have a roster consisting of at least 90% Doral Residents and proof of insurance with the City of Doral named additionally insured.

The reduced rate would be available for individual days as approved by the Parks and Recreation Department. The reduced rate will not be approved for leagues, tournaments or similar activities. Reservations for the reduced rate may be made no more than a month in advance and no less than two weeks prior to the requested date.
