The City of Doral authorizes the firm of A&P Consulting Transportation Engineers to provide professional engineering services for the all-way stop control warrant at the intersection of NW 84 Avenue/NW 27 Street and for the split phase removal at the intersection of NW 87 Avenue/NW 27 Street. The work should be performed in accordance with the contract provisions contained in the Continuing Professional Services Agreement between A&P Consulting Transportation Engineers and the City of Doral dated January 30, 2018, and the attached Proposal submitted by your firm for the above referenced project.

**SCOPE OF SERVICES AND SCHEDULE:**

The scope of the project will be as described in the attached proposal from A&P Consultant Transportation Engineers dated April 4, 2018 for the performance of the all-way stop control warrant at the intersection of NW 84 Avenue/NW 27 Street and for the split phase removal at the intersection of NW 87 Avenue/NW 27 Street. The schedule requires the draft report to be completed within 45 calendar days of the notice to proceed. All limitations of time set forth in this Work Order are of the essence. The performance of services associated with this Work Order will be executed on a Time and Materials basis with a not to exceed amount of \$17,228.00.

You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal, and revoke the award.

Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated January 30, 2018 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. Work Order is not binding until the City of Doral agrees and approves this Work Order.

**RESOLUTION No. 18-83**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER BETWEEN THE CITY OF DORAL AND A&P CONSULTING TRANSPORTATION ENGINEERS CORP. TO PROCEED WITH THE TRAFFIC ENGINEERING SERVICES FOR THE ALL-WAY STOP WARRANT ANALYSIS AT THE INTERSECTION OF NW 84 AVENUE AND NW 27 STREET AND THE SPLIT-PHASE REMOVAL AT THE INTERSECTION OF NW 87 AVENUE AND NW 27 STREET IN AN AMOUNT NOT EXCEED \$17,228.00; RECOGNIZING THAT A&P CONSULTING TRANSPORTATION ENGINEERS CORP. IS A CITY OF DORAL PRE-QUALIFIED VENDOR; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Public Works Department (“PWD”) for the City of Doral (the “City”) wishes to secure a firm to proceed with traffic engineering services for the warrant analysis of an all-way stop control at the intersection of NW 84 Avenue and NW 27 street as well as the split-phase removal at the intersection of NW 87 Avenue and NW 27 Street (the “Project”); and

**WHEREAS**, A&P Consulting Transportation Engineers Corp. is a prequalified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in November 2017; and

**WHEREAS**, Staff recommends that the City Council approve the Work Order with A&P Consulting Transportation Engineers Corp. to proceed with the traffic engineering services for the all-way stop warrant analysis at the intersection of NW 84 Avenue and NW 27 Street and the split-phase removal at the intersection of NW 87 Avenue and NW 27 Street in an amount not exceed \$17,228.00.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL  
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

**Section 2. Approval.** The Work Order between the City of Doral and A&P Consulting Transportation Engineers Corp. for the provision of traffic engineering services for the all-way stop warrant analysis at the intersection of NW 84 Avenue and NW 27 Street and the split-phase removal at the intersection of NW 87 Avenue and NW 27 Street; in an amount not to exceed \$17,228.00, a copy which is attached hereto as Exhibit "A", is hereby approved.

**Section 3. Authorization.** The City Manager is authorized to execute the work order and expend budgeted funds on the behalf of the City in furtherance hereof.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.


