A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN AMENDMENT TO WORK ORDER NO. 3 FOR KEITH & SCHNARS, A PREQUALIFIED CITY VENDOR, FOR THE PROVISION OF CONSTRUCTION ENGINEERING INSPECTION SERVICES ON THE NW 52 STREET (BETWEEN NW 107-NW 97 AVE) AND NW 102 AVENUE (BETWEEN NW 41 ST- NW 58 ST) ROADWAY IMPROVEMENTS PROJECT AND INCREASING FUNDING IN AN AMOUNT OF \$99,305.42; RECOGNIZING THAT KEITH & SCHNARS IS A CITY OF DORAL PRE-QUALIFIED VENDOR; AUTHORIZING THE CITY MANAGER TO EXECUTE THE AMENDED WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY IN FURTHERANCE HEREOF: PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") executed "Work Order No. 3" for Keith & Schnars to provide Construction, Engineering, and Inspection services ("CEI Services") for the Roadway Improvements project on NW 52 St. (NW 107 Ave. – NW 97 Ave.) and NW 102 Ave. (NW 41 St. – NW 58 St.) (the "Project") on September 16, 2015; and

WHEREAS, Keith & Schnars is a pre-qualified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in December 2014; and

WHEREAS, City staff has recommended that the City Council approves the amendment to Work Order No. 3 for Keith & Schnars, and the funding increase in an amount of \$99,305.42, to provide CEI services until the completion and close out of the Project.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS: <u>Section 1.</u> <u>Recitals</u>. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. <u>Approval</u>. Amendment of Work Order No. 3 for CEI Services of the construction of roadway improvements on NW 52 St. (NW 107 Ave. – NW 97 Ave.) and NW 102 Ave. (NW 41 St. – NW 58 St.), and increase funding in the amount of \$99,305.42, together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney, is hereby approved.

<u>Section 3.</u> <u>Authorization.</u> The City Manager is authorized to execute the Amended Work Order No. 3 and expend budgeted funds on behalf of the City in furtherance hereof.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.
