## RESOLUTION No. 15-164

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, ESTABLISHING AND ADOPTING A TENTATIVE MILLAGE RATE AND LEVY OF AD VALOREM TAXES FOR FISCAL YEAR 2015-2016 IN THE AMOUNT OF 1.9280 MILLS, WHICH IS 9.94% HIGHER THAN THE ROLL-BACK RATE TO BALANCE THE GENERAL FUND FOR FISCAL YEAR 2015-2016; ESTABLISHING THE ROLLED-BACK RATE TO BE 1.7537 MILLS; AND PROVIDING FOR AN EFFECTIVE DATE

**WHEREAS,** pursuant to Section 200.065, *Florida Statutes,* the City of Doral (the "City") has established a proposed millage rate; and

WHEREAS, on September 8, 2015, the City Council held a public hearing to consider any adjustment of its proposed millage rate, to adopt a tentative millage rate, and to adopt a tentative operating budget for Fiscal Year 2015-2016 ("FY 2015-2016"), in accordance with Section 200.065(2)(c), *Florida Statutes* and

**WHEREAS,** on September 23, 2015, the City Council held a public hearing to consider any adjustment of its tentative millage rate, to adopt a final millage rate, confirm its rolled-back rate and to adopt a final operating budget for FY 2015-2016, in accordance with Section 200.065(2)(d), *Florida Statutes*; and

WHEREAS, the City Council of the City of Doral establishes, pursuant to State law, a final millage rate to balance the budget for the General Fund for FY 2015-2016.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1</u>. <u>Recitals</u>. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Final Millage Rate. The City establishes a millage rate of \$1.9280 per \$1,000.00 of assessed property value within the City of Doral, to balance the budget for FY 2015-2016.

Section 3. Rolled-Back Rate. The City further confirms the rolled-back rate for FY 2015-2016 to be 1.7537 mills and the millage rate of 1.9280 mills to be 9.94% more than the rolled back rate.
