

RESOLUTION No. 08 – 30

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING A CHANGE ORDER TO THE AGREEMENT WITH URS CORPORATION IN AN AMOUNT NOT TO EXCEED \$31,000.00 FOR THE PROVISION OF ADDITIONAL STORMWATER DESIGN AND CONSTRUCTION ENGINEERING INSPECTION SERVICES FOR IMPROVEMENTS ALONG N.W. 102ND AVENUE; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral seeks to provide for the stormwater needs of its businesses and residents and, accordingly, has adopted a Stormwater Master Plan;

WHEREAS, the site located on N.W. 102nd Avenue between theoretical N.W. 53rd Street and N.W. 56th Terrace was identified on the City of Doral Stormwater Master Plan but the project was deleted from the County schedule due to its location on a City maintained street: and

WHEREAS, the City of Doral has decided to move forward with the construction of the improvements on N.W. 102nd Avenue requiring additional design and construction engineering inspection services under its current contract with URS Corporation (URS); and

WHEREAS, Staff respectfully requests that Council approve a change order to the agreement with URS in an amount not to exceed \$31,000.00 for the provision of additional stormwater design and construction engineering services for improvements along N.W. 102nd Avenue.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. The City Council of the City of Doral, Florida hereby approves a change order to the agreement with URS in an amount not to exceed \$31,000.00 for the provision of additional stormwater design and construction engineering services for improvements along N.W. 102nd Avenue.

Section 2. This Resolution shall take effect immediately upon adoption.


