### RESOLUTION NO. 12-116

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING THE FIVE (5)-YEAR CAPITAL IMPROVEMENT ELEMENT UPDATE AND THE CAPITAL IMPROVEMENT PROGRAM FOR FISCAL YEARS 2012-2013 THROUGH 2016-2017; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in December 2011, the Capital Improvement Planning Working Group was formed to establish the City's Capital Improvement Program (CIP) and during the months of June, July and August 2012, they met to review new and existing projects for consideration for inclusion as a new fifth year of the CIP for FY 2016-2017; and

WHEREAS, in order to avoid confusion, the Planning and Zoning Department is simultaneously submitting the 5-year Capital Improvement Element (CIE) update which is the method for tying the CIP into the City of Doral Comprehensive Development Master Plan (CDMP) and which ensures that concurrency requirements set forth by the CDMP are being met by projects contemplated in the CIP; and

WHEREAS, Staff respectfully requests that the City Council approve the 5-year CIE update (Exhibit A) and the CIP for Fiscal Years 2012-13 through 2016-2017 (Exhibit B).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1</u>. The City Council of the City of Doral hereby approves the 5-year CIE update and the CIP for Fiscal Years 2012-13 through 2016-2017 as presented herein as Exhibits A and B respectively.

**Section 2.** This Resolution shall become effective immediately upon adoption.
