A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A BUDGET TRANSFER IN THE AMOUNT OF \$10,000.00 FROM PARKS AND RECREATION — OTHER CURRENT CHARGES ACCOUNT 001.90005.500490 TO GENERAL GOVERNMENT — OTHER CURRENT CHARGES ACCOUNT 001.50005.500490 FOR THE PROVISION OF A DONATION TO THE AMERICAN CANCER SOCIETY; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") is a proud sponsor of the American Cancer Society; and

**WHEREAS**, the City has made annual contributions to the Relay for Life of Doral in the form of money and in-kind services for many years; and

**WHEREAS**, the Relay for Life of Doral has experienced a steady decline in attendance despite numerous efforts to reinvigorate participation; and

WHEREAS, City Staff performed a comprehensive assessment of the events costs and impact on the City's strategic initiatives; and

WHEREAS, during the FY 18-19 Strategic Planning Session, the recommendation to continue supporting the American Cancer Society as a sponsor of the 2018 Miami Gala held on April 21, 2018 was made; and

WHEREAS, the funding for the City's Relay for Life is currently budgeted in Parks and Recreation – Other Current Charges Account No. 001.90005.500490 in the amount of \$10,000.00; and

WHEREAS, the funds would need to be transferred to General Government –

Other Current Charges Account No. 001.50005.5490 to sponsor the American Cancer

Society 2018 Miami Gala held on April 21, 2018; and

WHEREAS, staff respectfully requests approval to transfer funds from Parks & Recreation – Other Current Charges Account No. 001.90005.500490 to General Government – Other Current Charges Account No. 001.50005.500490 in the total amount of \$10,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

**Section 1.** Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. The transfer of funds in the amount of \$10,000.00 from account 001.90005.500490 to account 001.50005.500490 to sponsor the American Cancer Society 2018 Miami Gala held on April 21, 2018 is hereby approved.
