

RESOLUTION NO. 13-64

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH THE CORRADINO GROUP, INC. TO PERFORM THE TRANSIT MOBILITY STUDY SERVICES IN AN AMOUNT NOT TO EXCEED \$70,000.00; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY WITH RESPECT TO THE AGREEMENT APPROVED HEREIN; RECOGNIZING THAT THE CORRADINO GROUP, INC. IS A CITY OF DORAL PRE-QUALIFIED VENDOR; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral Public Works Department wishes to secure a firm to perform The Transit Mobility Study Services to recommend improvements for a multimodal transportation strategy that is consistent with, and helps achieve, the City's vision and policies; and

WHEREAS, The Corradino Group, Inc. is a prequalified provider of professional services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in September 2011. Following a review of the experience and qualifications for the pool of prequalified firms, it was determined that the Corradino Group is the firm with the most relevant experience and the top selection to perform the Transit Mobility Study; and

WHEREAS, Staff respectfully requests that the city council authorize The Corradino Group, Inc., to perform The Transit Mobility Study Services in an amount not to exceed \$70,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recognizing that The Corradino Group, Inc., is a City of Doral pre-qualified vendor, the City Council of the City of Doral hereby authorizes the City Manager to negotiate and enter into an agreement with The Corradino Group, Inc., to perform The Transit Mobility Study Services to recommend improvements for a multimodal transportation strategy that is consistent with, and helps achieve, the City's vision and policies in an amount not to exceed \$70,000.00.


Section 2. The City Council further authorizes the City Manager to expend budgeted funds on behalf of the City with respect to the agreement approved herein.


