A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER WITH GPE ENGINEERING & GENERAL CONTRACTORS CORP. FOR THE **PROVISION OF SIDEWALK, CURB & GUTTER AND MISCELLANEOUS** CONCRETE REPAIRS ALONG CITY SECTION 18 IN AN AMOUNT NOT TO EXCEED \$51,953.00; WHICH INCLUDES A 10% CONTINGENCY FOR ANY UNFORESEEN CONDITIONS: RECOGNIZING GPE THAT ENGINEERING & GENERAL CONTRACTORS CORP. IS A PRE-QUALIFIED VENDOR: AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on April 21, 2022, the City of Doral ("City") issued and advertised Request for Qualification No. 2022-12 "Sidewalk, Curb & Gutter and Miscellaneous Concrete Repair Services" (the "RFQ"); and

WHEREAS, the evaluation committee recommended that the City Council award the RFQ to the top three (3) ranked firms, The American Design Engineering Construction Inc., GPE Engineering & General Contractor Corp., and Miliani Construction Corp; and

WHEREAS, in August 2022, pursuant to Resolution No. 22-143, the City Council accepted the recommendation of the evaluation committee and awarded the RFQ to the aforementioned firms, thereby establishing a pool of construction firms for "Sidewalk, Curb & Gutter and Miscellaneous Concrete Repair Services" ("Pre-qualified Pool of Firms"); and

WHEREAS, the Public Works Department ("PWD") is in need of a firm to provide Sidewalk, Curb & Gutter and Miscellaneous Concrete Repair Services along City Section 18 (the "Work"); and

WHEREAS, the PWD requested a proposal from the Pre-Qualified Pool of Firms for the Work; and

WHEREAS, GPE Engineering & General Contractors Corp. provided the attached proposal and was deemed the lowest bidder with a not to exceed amount of \$51,953.00, which includes a 10% contingency for any unforeseen conditions; and

WHEREAS, City staff respectfully requests that the Mayor and the City Councilmembers approve Work Order No. 14 with GPE Engineering & General Contractors Corp., a copy of which is attached hereto as Exhibit "A", for the provision of Sidewalk, Curb & Gutter and Miscellaneous Concrete Repair Services along Section 18 in an amount not to exceed \$51,953.00, which includes a 10% contingency for any unforeseen conditions; and

WHEREAS, funding for this request is available in the Public Works Department Transportation Fund, Account Num. 101.80005.500633.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The City Council hereby approves Work Order No. 14 to GPE Engineering & General Contractors Corp. for Sidewalk, Curb & Gutter and

Miscellaneous Concrete Repair Services along City Section 18, in an amount not to exceed \$51,953.00, which includes a 10% contingency for any unforeseen conditions, a copy of which is attached hereto as Exhibit "A", together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney.

Section 3. Authorization. The City Manager is authorized to execute the work order and expend budgeted funds on behalf of the City in an amount not to exceed \$51,953.00.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.

The City of Doral authorizes the firm of GPE Engineering & General Contractors Corp. (GPE) to proceed with the provision of Construction Services for the repair of "Section 18 Sidewalk Repairs". Where GPE is a pre-qualified provider of Construction Services selected in accordance with RFQ 2022-12 requirements and approved by the City Council on August 9, 2022, through Resolution 22-143. The work should be performed in accordance with the contract provisions contained in the Construction Services Agreement between GPE and the City of Doral dated August 9, 2022, and the attached Proposal submitted on November 8, 2023, submitted by your firm for the above referenced project.

SCOPE OF SERVICES AND SCEHDULE:

The scope of the project will be as described in the attached proposal from GPE submitted on November 8, 2023. The schedule requires the work to be performed within 30 calendar days from NTP. All limitations of time set forth in this Work Order are of the essence. The performance of services associated with this Work Order will be executed based on the schedule of values submitted by GPE with a not to exceed amount of \$51,953.00 which includes a 10% contingency amount for any unforeseen conditions.

You are required by the Continuing Construction Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal and revoke the award. Work Order incorporates the terms and conditions set forth in the Continuing Construction Agreement dated August 9, 2022, between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Construction Agreement, the provisions of this specific Work Order shall prevail and apply.

This Work Order is not binding until it is fully executed by the City of Doral.

IN WITNESS WHEREOF, the parties hereto have executed this Agreement on the day and date first above written, in two (2) counterparts, each of which shall, without proof or accounting for the other counterpart be deemed an original Contract.
