RESOLUTION No. 20-39

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY'S CODE OF ORDINANCES. ADOPTING THE GSA CONTRACT No. GS-35F-053-0537X WITH CLOUD COMPUTING CONCEPTS LLC, FOR THE PROVISION OF MANAGED ROUTER SERVICES. REDUNDANT INTERNET ACCESS. CONNECTS, AND A STANDALONE 100 SQUARE FOOT CAGE, WHICH CONSIST OF RACKS, CRITICAL SERVER HARDWARE, POWER, AND SERVICES FOR DISASTER RECOVERY AND A GREATER LEVEL OF SECURITY FOR OUR TECHNOLOGY INFRASTRUCTURE AT THE NAP IN AN AMOUNT NOT TO EXCEED BUDGETED FUNDS, FOR THE PERIOD SET FORTH AND ANY APPROVED ADDITIONAL SUBSEQUENT EXTENSIONS; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") has a need to protect its critical data and information technology infrastructure from security breaches, as well as damage and/or destruction due to natural disaster and other catastrophic events; and

WHEREAS, On March 18th, 2015 Council Meeting, the Mayor and City Council members approved Resolution No. 15-46, for an agreement with Miami Dade Broadband Coalition for the provision of manage router services, internet access and hardware colocation space at the NAP of the Americas (NAP), As part of the Fiscal Year 2015-16 strategic initiatives, the City's Information Technology Department implemented the FPL Fibernet Wide Area Network high speed fiber optic services which requires cross connects at the NAP and recommended the City move its critical server hardware to a standalone 100 square foot cage, which consist of additional racks and power for a greater level of security for our technology infrastructure; and

WHEREAS, On August 15, 2018, Miami Dade Broadband Coalition and Cloud

Computing Concepts, entered into an Asset Purchase Agreement dated April 9, 2018. Effective July 16, 2018, the Federal Communications Commission in WC Docket No. 18-185, consented to the closing of the transaction. The City continued to receive invoices from Miami Dade Broadband Coalition until GSA contract transition to Cloud Computing Concepts was completed. Current services at the NAP continue operational without increase in cost and invoice payments will now be issued to Cloud Computing Concepts, LLC; and

WHEREAS, The Information Technology department respectfully recommends the Mayor and City Council adopt the GSA Contract #: GS-35F-053-0537X, Cloud Computing Concepts, LLC., for the provision of managed router services, redundant internet access, cross connects, a standalone 100 square foot cage, which consist of racks, critical server hardware, power, and services for disaster recovery and a greater level of security for our technology infrastructure at the NAP in an amount not to exceed budgeted funds, for the period set forth and any approved additional subsequent extensions; and

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

<u>Authorization.</u> Pursuant to Section 2-322 of the City Code, Staff respectfully requests that the Mayor and the City Council approve the use contracts competitively entered into by other governmental entities in a manner similar to that set forth in Chapter 2, Article V, of the City Code, and vendors participating in GSA Contract

#: GS-35F-053-0537X, awarded under Federal Supply Schedule 70 General Purpose Commercial Information Technology Equipment, Software and Services. The Department further requests that the Mayor and City Council adopt GSA Contract #: GS-35F-053-0537X, Cloud Computing Concepts, LLC., for the period set forth and any approved additional subsequent extensions.

Section 3. Implementation. The City Manager is hereby authorized to enter into an agreement and other contractual documents, subject to approval as to form and legal sufficiency by the City Attorney.
