

**RESOLUTION No. 21-227**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY LOUD AND LIVE, INC. TO HOST THE 2022 DOWNTOWN DORAL COMMUNITY FESTIVAL EVENT AT DOWNTOWN DORAL PARK, LOCATED AT 8395 NW 53 STREET, DORAL, FL 33166 ON FRIDAY, JANUARY 21, 2022 AND SATURDAY, JANUARY 22, 2022, FROM 7:30 AM TO 1:00 PM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Heather McGlaughlin on behalf of Loud and Live, Inc. (the “Applicant”) seeks approval from the City of Doral for a Special Event Permit to host the “2022 Downtown Doral Community Festival”; and

**WHEREAS**, staff recommends that the Mayor & City Council approve the proposed Special Event Permit to host the “2022 Downtown Doral Community Festival” Friday, January 21, 2022 and Saturday, January 22, 2022 at Downtown Doral Park, located at 8395 NW 53 Street, Doral, FL 33166, from 7:30 a.m. to 1:00 p.m.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated herein.

**Section 2. Approval.** The outdoor event permit for the “Downtown Doral Community Festival” is hereby approved subject to the following conditions:

1. Applicant shall comply with comments made by the City of Doral Police and Park’s Departments and pay all applicable fees.
2. Applicant shall obtain all required permits.
3. Applicant shall be required to have all inspections and approvals prior to the event date.

4. Applicant shall provide to the City of Doral an acceptable certificate of insurance four weeks prior to the event date.

**Section 3. Effective Date.** This Resolution shall take effect immediately upon adoption.
