

RESOLUTION NO. 14-111

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA ADOPTING THE COMPETITIVELY BID TERMS OF THE AGREEMENT FOR MIAMI-DADE COUNTY FOR THE PROVISION OF PURCHASING 10 HARRIS SCAN PORTABLE POLICE RADIOS IN AN AMOUNT NOT TO EXCEED \$38,000.00; DIRECTING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH MIAMI-DADE COUNTY ON THE BASIS OF SAID TERMS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the ITB #2014-10 was issued on February 26, 2014 for the purchase of 10 Harris Scan Portable Police Radios, with accessories and programming. One (1) Bid was received and opened on March 19, 2014, with the company meeting the required criteria; and

WHEREAS, pursuant to Section 2-322 of the City Code, Staff respectfully requests that the City Council adopt the competitively bid terms of the agreement for Miami-Dade County for the provision of purchasing 10 Harris Scan Portable Police Radios, with accessories and programming in an amount not to exceed \$38,000.00. This purchase is funded in account 001.60005.500640 Capital Outlay with funding available after a budget transfer of \$13,000.00 from account 001.60005.500410 Communications and Freight; and

WHEREAS, Staff further requests that the City Council authorize the City Manager to negotiate and enter into an agreement with Miami-Dade County on the basis of said terms.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. The City Council of the City of Doral hereby adopts the competitively bid terms of the agreement for Miami-Dade County for the provision of purchasing 10

Harris Scan Portable Police Radios in an amount not to exceed \$38,000.00. This purchase is funded in account 001.60005.500640 Capital Outlay with funding available after a budget transfer of \$13,000.00 from account 001.60005.500410 Communications and Freight.

Section 2. The City Council of the City of Doral further directs the City Manager to negotiate and enter into an agreement with Miami-Dade County on the basis of said terms.

Section 3. This Resolution shall take effect immediately upon adoption.
