A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AWARDING OF REQUEST FOR PROPOSALS #2017-17 "RECREATIONAL PROGRAMS PHASE 2" FOR DORAL LEGACY PARK TO THE TOP RANKED FIRMS; AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH SIMAN ORCHESTRA FOUNDATION, HOLISTIC SYSTEMS, CHESS FOR KIDS, SHOTOKAN KARATE, AND ENERGY YOGA FOR A TERM OF THREE (3) YEARS WITH THE OPTION FOR TWO (2) ADDITIONAL ONE (1) YEAR TERMS FOR A POSSIBLE TOTAL OF FIVE (5) YEARS; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, On June 15, 2017, Request for Proposals #2017-17, "Recreational Programs Phase 2" was advertised for the provision of providing recreational programming for youth, adults, and seniors of any and all abilities; and

WHEREAS, Six (6) proposal submittals were received on July 19th, 2017 with all proposals meeting the required criteria; and

WHEREAS, an evaluation meeting was held on July 24th, 2017 where all submitted proposals were scored and ranked. The evaluation committee determined that based on a Three Hundred (300) Point System with a possibility of Ten (10) extra points for each of the following: "Doral Based", "Miami-Dade/Broward County Based", "Certified Minority Business" or "Certified Veteran Business" the firms ranked as follows:

1.	Siman Orchestra Foundation	299.0 Points
2.	Holistic Systems	286.5 Points
3.	Chess for Kids	270.5 Points
4.	Shotokan Karate	265.5 Points
5.	Energy Yoga	262.0 Points

WHEREAS, Staff respectfully requests the approval to award Request for Proposals #2017-17 "Recreational Programs Phase 2" for all City parks to the top ranked

firm and authorize the City Manager to negotiate and enter into an agreement with Siman Orchestra Foundation, Holistic Systems, Chess for Kids, Shotokan Karate, and Energy Yoga for the provision of providing recreational programming for youth, adults, and seniors of any and all abilities for a period of three (3) years with the option for two (2) one (1) year renewals, for a possible total of five (5) years.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Award. Request for Proposals #2017-17 is hereby awarded to Siman Orchestra Foundation, Holistic Systems, Chess for Kids, Shotokan Karate, and Energy Yoga for the provision of providing recreational programming for youth, adults, and seniors of any and all abilities. This award, in and of itself, does not vest any of the named proposers with any vested rights absent entering into an agreement with the City for the desired services.

Section 3. Authorization to Procure Services. The City Manager is hereby authorized to negotiate and enter into an agreement with Siman Orchestra Foundation, Holistic Systems, Chess for Kids, Shotokan Karate, and Energy Yoga for the provision of providing recreational programming for youth, adults, and seniors of any and all abilities for a period of three (3) years with the option for two (2) one (1) year renewals, for a total of five (5) years. The agreement is subject to approval by the City Attorney as to form and legal sufficiency and on such other terms and conditions as may be appropriate to protect and further the interests of the City. This Authorization does not create or confer any rights to Siman Orchestra Foundation, Holistic Systems, Chess for Kids, Shotokan

Karate, and Energy Yoga or any of the other ranked firms.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

Section 5. Effective Date. This resolution shall take effect immediately upon adoption.
