



CITY OF DORAL EMERGENCY ORDER No. 2021-15

WHEREAS, on March 25th, 2020 the City of Doral declared a local State of Emergency; and

WHEREAS, the City recognizes the impact of economic hardship, but the risk of COVID-19 infection is still real for all Floridians; and

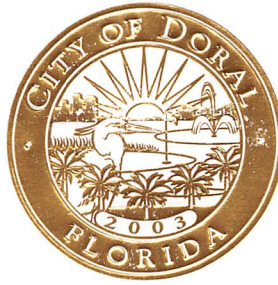
WHEREAS, the orders closing certain business establishments, imposing a curfew, and expanding the application of physical distancing and facial covering requirements served to mitigate the spread of COVID-19 and reduce the daily positivity rate and number of people in hospitals, in ICU beds, and on ventilators; and

WHEREAS, on September 25th, 2020, the Governor of Florida issued Executive Order Number 20-244, moving the State of Florida into Phase 3 of the State's reopening plan;

WHEREAS, on September 26th, 2020, the Mayor for Miami-Dade County issued Emergency Order 30-20 in order to comply with the Governor's Executive Order moving Miami-Dade County into Phase 3;

WHEREAS, the City of Doral will be following the Miami Dade County, "The Moving to A New Normal Handbook" guidelines for businesses within the City.

WHEREAS, the City Charter grants to the Mayor in a State of Emergency the authority to take actions as may be necessary to protect the lives and health of the citizens of Doral.



THEREFORE, under Section 1.04 of the City Charter, and the home rule powers permitted under the Constitution and laws of the State, the City of Doral will open and implement the County's reopening plan, as Mayor, I hereby order:

Section 1. Executive Order Extending the Declaration of Local State of Emergency. The Declaration of the State of Local Emergency is extended for seven (7) days if not cancelled before that period of time. Concurrent with this Declaration is the authority to take the actions set forth in those Emergency Orders, for the duration of this Declaration.

Section 2. Extending the Reopening guidelines. This Emergency Order adopts reopening guidelines set forth in Miami Dade County Emergency Order 33-20.

Every retail and commercial establishment and any other establishment or facility (collectively, "establishment") in the City of Doral is permitted to open, and remain open, provided that each such establishment:

- a. complies with the facial covering requirements in Section 3 below, as amended;
- b. provides hand sanitizer for customers and employees or facilities for hand-washing;
- c. uses reasonable efforts to ensure that customers and employees on site maintain appropriate social distancing, as recommended by the current CDC guidance, particularly in checkout, pick-up, or take-out areas, and also in employee breakrooms and common use areas.



Reasonable efforts may include, but are not limited to, marking floors at appropriate intervals or providing other visible systems to allow persons to maintain proper social distancing; and

- d. ensures that sick employees do not report to work.

Section 3. Masks and other facial coverings.

1. All persons in public spaces and places, both indoors and outdoors, shall be required to wear facial coverings, as defined in Miami-Dade County Emergency Order 33-20, as amended except as set forth in Section 2 below.
2. Facial coverings shall not be required;
 - a. at or inside a private residence;
 - b. inside a private automobile;
 - c. at or inside any religious institution, without limitation, though voluntary usage of masks is encouraged;
 - d. inside a hotel, motel, or commercial lodging establishment guest room, or inside any apartment;
 - e. of children under the age of two years;
 - f. of persons who cannot wear a mask or facial covering due to an existing medical condition;
 - g. of an individual who is hearing impaired or an individual who is communicating with an individual who is hearing impaired;



- h. where Federal or State safety or health regulations prohibit the wearing of facial coverings;
 - i. of persons actively engaged in organized sporting competitions or activities, whether indoor or outdoor; facial coverings must be put on by athletes and other individuals standing on the sidelines of sports competitions;
 - j. of persons swimming or engaged in other activities which may cause the facial covering to become wet;
 - k. while persons are actively eating, drinking, or smoking;
 - l. while a person is receiving services which require access to that person's nose or mouth;
 - m. if a person is outdoors, has a mask available, and is a minimum of 10 feet from any other person other than members of that person's family, as defined above.
3. Persons attending religious services are urged, but are not required, to practice social distancing, such as keeping 6 feet between persons and limiting group size to that necessary to accomplish physical distancing.

Section 4. Parks and Outdoor Recreation.

1. The following park facilities are open, provided appropriate use of facial covering, frequent use of hand hygiene and social distancing is maintained. Facial coverings are not required:
- a. Picnic, shelter areas and grills may be used;



- b. Splashpad;
- c. Playgrounds;
- d. Athletic facilities;
- e. Seating on bleachers is allowed, (spectators that are not members of the same household or party must maintain social distancing).

2. The following activities are allowed, provided appropriate use of facial covering, frequent use of hand hygiene and social distancing is maintained.

- a. Organized group activities and athletics are permitted;
- b. Canopies and tents are allowed;
- c. Fishing is allowed;
- d. Individual and team instruction and competitions may resume;
- e. Golf cart pairings of two riders are allowed.
- f. Clubhouses may reopen;
- g. Locker room use is allowed.

Section 5. Curfew.

The general curfew from 12:00 a.m. to 6:00 a.m. is still in effect until further notice.



If any section, subsection, clause, or provision of this Order is held invalid or unenforceable, the remainder of this Order shall not be affected and every other section, subsection, clause, and provision of this Order shall be valid and enforced to the fullest extent permitted by law.

The Emergency measures that have been ordered and promulgated above shall be effective commencing on April 6th, 2021 and shall be effective through April 12th, 2021 unless extended.
