

**RESOLUTION No. 19-253**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER BETWEEN THE CITY OF DORAL AND PEVIDA HIGHWAY DESIGNERS, INC. TO PROCEED WITH THE DEVELOPMENT OF PROCUREMENT DOCUMENTS FOR THE PEDESTRIAN BRIDGE OVER DORAL BOULEVARD IN AN AMOUNT NOT EXCEED \$171,166.00; RECOGNIZING THAT PEVIDA IS A CITY OF DORAL PRE-QUALIFIED VENDOR; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Public Works Department (PWD) presented conceptual designs to City Council at the June 22, 2016 Zoning Council meeting where the preferred option currently under design was selected; and

**WHEREAS**, in February 2017, the PWD applied for grant funding through the Florida Department of Transportation (FDOT) Transportation Alternative Program (TAP) Grant; and

**WHEREAS**, on June 22, 2017 the City was notified that it was awarded \$1 million dollars towards the project and the funds were allocated in FDOT's FY 2023; and

**WHEREAS**, the City requested FDOT to bring the funding forward in order to procure the services of a design-build team and begin construction in FY 2020-21; and

**WHEREAS**, at the January 17, 2019 Parks Bond Workshop, City Council made suggestions that would alter the current approved concept; and

**WHEREAS**, the PWD with Pevida Highway Designers presented to Council conceptual renderings for the Council to select a new preferred option in order to update the criteria package and prepare the project for advertisement; and

**WHEREAS**, At the April Council meeting, the Council selected option 3 attached for the design criteria package to be updated and procurement documents to be developed; and

**WHEREAS**, Staff respectfully requests that the City Council approve the Work Order with Pevida to proceed with the development of the procurement documentation for the Pedestrian Bridge over Doral Boulevard; in an amount not to exceed \$171,166.00. Funds for these services will be allocated from the Park Bond Fund in Fiscal Year 2019-20 in account number 303.9000572.500650

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

**Section 2. Approval.** The Work Order between the City of Doral and Pevida Highway Designers, Inc. for the provision of development of the procurement documents; in an amount not to exceed \$171,166.00, a copy which is attached hereto as Exhibit "A", is hereby approved. Funds for these services will be allocated from the Park Bond Fund in Fiscal Year 2019-20 in account number 303.9000572.500650

**Section 3. Authorization.** The City Manager is authorized to execute the work order and expend budgeted funds on the behalf of the City.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.

The City of Doral authorizes the firm of Pevida Highway Designers, LLC to proceed with the provision of professional engineering services for the development of procurement documents, NEPA evaluation, and providing services as owner’s representative during the bidding process. The work should be performed in accordance with the contract provisions contained in the Continuing Professional Services Agreement between Pevida Highway Designers, LLC and the City of Doral dated February 16, 2018, and the attached Proposal submitted by your firm for the above referenced project.

**SCOPE OF SERVICES AND SCEHDULE:**

The scope of the project will be as described in the attached proposal dated September 19, 2019 from Pevida Highway Designers, LLC. The schedule requires the work to be performed within 6 months from Notice to Proceed. All limitations of time set forth in this Work Order are of the essence. The performance of services associated with this Work Order will be executed on a lump sum basis with a not to exceed amount of \$171,166.00.

You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal and revoke the award.

Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated February 16, 2018 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. This Work Order is not binding until the City of Doral agrees and approves this Work Order.

IN WITNESS WHEREOF, the parties hereto have executed this Agreement on the day and date first above written, in three (3) counterparts, each of which shall, without proof or accounting for the other counterpart be deemed an original Contract.
