RESOLUTION No. 08 – 10

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA WAIVING THE REQUEST FOR PROPOSALS PROCESS AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH MIAMI-DADE COUNTY FOR THE PROVISION OF HANDHELD EQUIPMENT, BASE STATIONS, SOFTWARE AND PROGRAMMING FOR RADIO COMMUNICATIONS FOR THE USE OF THE CITY OF DORAL POLICE DEPARTMENT IN AN AMOUNT NOT TO EXCEED \$626,769.00; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral seeks to provide for the immediate needs of the City of Doral police department to ensure quality and continuity of police service; and

WHEREAS, the Miami-Dade County Enterprise Technology Services Department is the sole provider of software and programming for all radio communications employed by the Miami-Dade Police Department and purchase from the County is needed to ensure capability of the City's current system of emergency radio communications; and

WHEREAS, Staff respectfully requests that Council waive the Request for Proposals Process consistent with Section 12-9 and authorize the City Manager to negotiate and enter into an agreement with Miami-Dade County for the provision of handheld equipment, base stations, software and programming for radio communications for the use of the City of Doral Police Department in an amount not to exceed \$626,769.00.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. The City Council of the City of Doral, Florida hereby waives the Request for Proposals process and authorizes the City Manager to negotiate and enter

into an agreement with Miami-Dade County for the provision of handheld equipment, base stations, software and programming for radio communications in an amount not to exceed \$626,769.00.

Section 2. This Resolution shall take effect immediately upon adoption.
