A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AWARDING INVITATION TO BID# 2016-26 "POLICE MESSAGE BOARD" TO APPLIED CONCEPTS INC., THE LOWEST. MOST RESPONSIBLE AND RESPONSIVE BIDDER: AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH APPLIED CONCEPTS, INC., SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY, FOR THE PROVISION OF A LARGE ELECTRONIC MESSAGE BOARD, IN AMOUNT NOT TO EXCEED \$16,148.00, AND TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City"), by and through its Police Department, regularly rents and uses electronic message boards ("Message Boards") to provide residents with information regarding a variety programs, special events, road closures, safety measures, holiday details, school traffic zone information and policing campaigns; and

WHEREAS, with the frequency of the use increasing, the administration has made the determination that it makes financial sense to purchase the Message Boards instead of renting them; and

WHEREAS, the City issued Invitation To Bid # 2016-26, "Police Message Board" (the "ITB"), on July 25, 2016 for the purpose of purchasing a Solar Powered Message Board for the Police Department, for which four (4) submittals were received and opened on the August 19, 2016 deadline, with all the firms meeting the required criteria; and

WHEREAS, Applied Concepts, Inc. was the lowest, most responsible and responsive Bidder, with its submittal of a "Stalker Message Center 360" deemed to be the best value due to the Larger Message Panel (4' X 8') and Four (4) Batteries which will

provide continuous power for twenty-one (21) days; and

WHEREAS, staff has recommended that the City Council award the ITB to Applied Concepts, Inc. and authorize the City Manager to negotiate and enter into an agreement for the purchase of Stalker Message Center 360 Message Board

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. <u>Award.</u> The ITB is hereby awarded to Applied Concepts, Inc. for the provision of Stalker Message Center 360 Message Board, pursuant to its bid. This award in and of itself does not confer any rights on Applied Concepts, Inc.

<u>Section 3.</u> <u>Authorization to Procure Services.</u> The City Manager is hereby authorized to negotiate with Applied Concepts Inc., as the top ranked firm, and enter into an agreement, subject to approval by the City Attorney, as to form and legal sufficiency, for the provision of large electronic message board, for an amount not to exceed \$16,148.00 and to expend budgeted funds in furtherance hereof.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 5. Effective Date. This resolution shall take effect immediately upon adoption.
