A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE HOSTING OF THE JR. DOLPHINS FOOTBALL SUMMER CAMP AT DORAL LEGACY PARK AND WAIVING FIELD RENTAL FEES; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") is an active member of the Miami Xtreme
Youth Football League where the Doral Broncos Tackle Football Program participates in;
and

WHEREAS, in partnership with the Miami Xtreme Youth Football League, the City was approached by the Miami Dolphins again to be the host site for their 2019 Jr. Dolphins Football Summer Camp; and

WHEREAS, the camp will be held at Doral Legacy Park on July 15-18, 2019 and have a maximum capacity of 200 campers; and

WHEREAS, the Miami Dolphins have agreed to provide 15 free camp registrations, which will be awarded to Doral Broncos Football participants and 50 reserved spaces in the camp specifically for Doral residents; and

WHEREAS, staff finds that hosting this camp would be beneficial to the continued growth of the City's Doral Broncos Tackle Football Program and is respectfully requesting the approval to host the camp and waive the associated field rental fees.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.
