

**RESOLUTION NO. 11 – 135**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA WAIVING THE COMPETITIVE PROCUREMENT PROCESS AND ADOPTING THE TERMS OF THE EXISTING AGREEMENT BETWEEN THE STATE OF FLORIDA AND SPRINT SOLUTIONS, INC. FOR THE PROVISION OF AIR CARD SERVICES FOR THE CITY OF DORAL POLICE DEPARTMENT IN AN AMOUNT NOT TO EXCEED \$48,600.00; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the State of Florida has a current competitively bid agreement with Sprint Solutions, Inc. (Sprint) for the provision wireless communication services and equipment; and

**WHEREAS**, pursuant to the City of Doral Purchasing and Procurement Ordinance #2004-03, Staff respectfully requests that the City Council adopt the terms of the existing agreement between the State of Florida and Sprint for the provision of air card services for the City of Doral Police Department in an amount not to exceed \$48,600.00.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1.** The City Council hereby waives the competitive procurement requirements and adopts the terms of the existing agreement between the State of Florida and Sprint for the provision of air card services for the City of Doral Police Department in an amount not to exceed \$48,600.00.

**Section 2.** This Resolution shall become effective immediately upon its adoption.
