A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING AN EXTENSION TO THE FARMERS' MARKET PERMIT FOR ECOTEM INC. TO BE HELD AT 10311 NW 58TH STREET, DORAL, FLORIDA ON SATURDAYS FROM MARCH 6TH, 2010 TO APRIL 24TH, 2010 BETWEEN THE HOURS OF 9:00 A.M. TO 2:00 P.M.; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS; EcoTem Inc. ("Applicant") is requesting an extension to the farmers' market originally approved via Resolution No. Z09-13; and

WHEREAS, Staff respectfully recommends that Council approves the extension to farmers' market being held at 10311 NW 58th Street, Doral, Florida, on Saturdays from March 6th, 2010 to April 24th, 2010 from 9:00 am to 2:00 pm the City of Doral for Farmers' Market; and

WHEREAS, on February 10th, 2010, the City Council held a public hearing and after careful review and deliberation, including a review of staff's recommendation, determined that it is in the best interests of the citizens of the City of Doral to approve the above referenced requests; subject to the following conditions;

- Construction plans for tents (larger than 10 X 10) and any structural facility must be submitted to the Building Department for approval.
- 2. Applicant shall obtain electrical permit for the generator if required by the Building Department.
- 3. All City and State Licenses must be obtained prior to the opening of the Market.
- 4. All trash and refuse must be must be removed from the site at the end of each day.

- 5. If safety and traffic circulation become problematic according to the City of Doral Police, the Farmers' Market shall coordinate and hire officers and/or or secure private security in a manner satisfactory with the City of Doral Police.
- 6. Based on the number of parking spaces, the maximum number of vendors is limited to 25. However, Staff may approve additional vendors based on staff analysis of the site's parking utilization and circulation for the market.
- 7. Lighting must be provided during morning set up prior to sunrise.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. The City Council of the City of Doral, Florida hereby approves the extension to the farmers' market permit for EcoTem Inc. subject to the conditions listed in the above "whereas" clause.

Section 2. This Resolution shall take effect immediately upon adoption.
