All residents, property owners and other interested parties are hereby notified of a **Council Meeting** on <u>Wednesday, March 22, 2017, beginning at 6:00 PM</u>. A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE FINAL PLAT FOR LANDMARK AT DORAL CENTRAL, LOCATED ON BOTH SIDES OF NW 66 STREET, BETWEEN APPROXIMATELY NW 102 PATH AND APPROXIMATELY NW 104 PATH, CITY OF DORAL, FLORIDA; PROVIDING FOR RECORDATION; AND PROVIDING FOR AN EFFECTIVE DATE

APPLICANT: Ford, Armenteros & Fernandez, Inc. on behalf of Lennar Homes, LLC and the Landmark at Doral Community Development District.

PROJECT NAME: Landmark at Doral Central

LOCATION: The subject property is located on both sides of NW 66 Street, between approximately NW 102 Path and approximately NW 104 Path, City of Doral, Florida. SIZE OF PROPERTY: 13.72 ± acres

PRESENT ZONING: Traditional Neighborhood District (TND)

**REQUEST:** Ford, Armenteros & Fernandez, Inc. on behalf of Lennar Homes, LLC and the Landmark at Doral Community Development District are requesting approval of the Final Plat for Landmark at Doral Central Replat.



All persons are invited to appear at this meeting or be represented by an agent, or to express their views in writing addressed to the City Clerk, **8401 NW 53rd Terrace, Doral, FL. 33166**. Maps and other data pertaining to these applications are available for public inspection during normal business hours in City Hall. Any persons wishing to speak at a public hearing should register with the City Clerk prior to that item being heard. Inquiries regarding the item may be directed to the Planning and Zoning Department at 305-59-DORAL.

Pursuant to Section 286.0105, Florida Statutes if a person decides to appeal any decisions made by the City Council with respect to any matter considered at such meeting or hearing, they will need a record of the proceedings and, for such purpose, may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based. This notice does not constitute consent by the City for introduction or admission of otherwise inadmissible or irrelevant evidence, nor does it authorize challenges or appeals not otherwise allowed by law. In accordance with the Americans with Disabilities Act, all persons who are disabled and who need special accommodations to participate in this meeting because of that disability should contact the Planning and Zoning Department at 305-59-DORAL no later than three (3) business days prior to the proceeding.
