RESOLUTION NO. 13-101

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA ESTABLISHING AND ADOPTING A TENTATIVE MILLAGE RATE AND LEVY OF AD VALOREM TAXES FOR FISCAL YEAR 2013-2014 IN THE AMOUNT OF 1.9280 MILLS, WHICH IS 6.35% LESS THAN THE ROLL-BACK RATE TO BALANCE THE GENERAL FUND FOR FISCAL YEAR 2013-2014; ESTABLISHING THE ROLLED BACK RATE TO BE 2.0587 MILLS; AND ESTABLISHING WEDNESDAY, SEPTEMBER 25, 2013 AS THE DATE THAT A FINAL BUDGET PUBLIC HEARING WILL BE HELD AT 5:01 P.M. AT THE CITY OF DORAL, CITY HALL COUNCIL CHAMBERS, 8401 NW 53RD TERRACE, DORAL FLORIDA 33166; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, pursuant to Section 200.065, *Florida Statutes* the City of Doral, Florida (the "City") has established a proposed millage rate; and

WHEREAS, pursuant to Section 200.065(2)(c), *Florida Statutes*, within eighty (80) days of certification of taxable value the City must re-compute the proposed millage rate and adopt a tentative millage rate; and

WHEREAS, the City Council establishes, pursuant to State law, a tentative millage rate to balance the budget for Fiscal Year 2013-2014; and

WHEREAS, in furtherance of State law the City has confirmed its rolled-back rate and established a time and place for a public hearing on the City's millage rate and budget.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA:

<u>Section 1</u>. <u>Recitals</u>. The foregoing recitals are true and correct and incorporated herein by this reference.

<u>Section 2</u>. <u>Tentative Millage Rate</u>. The Fiscal Year 2013-2014 tentative millage rate of the City is \$1.9280 per \$1,000.00 of assessed property value within the City of Doral, and establishes Wednesday, September 25, 2013 at 5:01 pm, as the date

and time of a final public hearing when the City Council will receive comments from residents and business owners regarding the final budget and millage rate.

<u>Section 3.</u> Rolled Back Rate. The rolled-back rate for the Fiscal Year 2013-2014 is 2.0587 mills and the tentative millage rate of 1.9280 mills is 6.35% less than the rolled back rate.

<u>Section 4.</u> <u>Hearing Date & Time</u>. The date and time of the public hearing to consider the final millage rate and budget will be Wednesday, September 25th 2013 at 5:01 pm at the City Hall Council Chambers, located at 8401 N.W. 53rd Terrace, Doral, FL 33166.

<u>Section 4.</u> <u>Effective Date.</u> This Resolution shall become effective upon adoption.
