

**RESOLUTION No. 17-110**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXTEND THE CONTRACT WITH TSO MOBILE FOR THE INSTALLATION AND MAINTENANCE OF SAFETY AND SECURITY DEVICES ON TROLLEYS ON A MONTH TO MONTH BASIS UNDER THE SAME TERMS AND CONDITIONS AS THE EXISTING AGREEMENT IN AN AMOUNT NOT TO EXCEED THE DEPARTMENTAL BUDGET; AUTHORIZING THE CITY MANAGER TO EXTEND THE AGREEMENT AND TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY WITH RESPECT TO THE AGREEMENT APPROVED HEREIN; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral (the “City”) entered into a five (5) year contract with two (2) one-year (1) options to extend with Tracking Solutions Corp. (“TSO Mobile”) for the installation and maintenance of safety and security devices on the Doral Transit System (“DTS”); and

**WHEREAS**, on July 12, 2016, the City executed the final option-to-extend which will expire on August 30, 2017; and

**WHEREAS**, during the contract period, TSO Mobile has provided exceptional service to the DTS, and often times has gone beyond their contractual obligations by providing additional technology and upgrades to DTS at no additional cost to the City; and

**WHEREAS**, due to their local presence and lack of a local competitor, TSO Mobile remains the only viable vendor in order to ensure quick response when Trolley technology hardware requires service and to minimize down time; and

**WHEREAS**, to ensure the technology component will meet the City’s needs, the Public Works Department (“PWD”) has been working with the City’s Information Technology Department along with the Procurement Division to draft a better contract to include unit prices; and

**WHEREAS**, in an effort to continue to provide trolley tracking services to the DTS, the PWD has recommended for the existing agreement between the City of Doral and TSO Mobile to be extended on a month to month basis under the same terms and conditions of the existing agreement in amount not to exceed the departmental budget, while staff renegotiates a new five (5) year Contract Agreement with TSO Mobile.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

**Section 2. Approval.** The extension of existing agreement between the City of Doral and TSO Mobile for the for the installation and maintenance of safety and security devices on a month to month basis under the same terms and conditions of the existing agreement in an amount not to exceed the departmental budget is hereby approved.

**Section 3. Authorization.** The City Manager is authorized to execute the month to month contract agreement with TSO Mobile under the same terms and conditions of the existing agreement and expend budgeted funds on the behalf of the City.

**Section 4. Implementation.** The City Manager and City Attorney are hereby authorized to take such action as may be necessary to implement the purpose and the provisions of this resolution.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Rodriguez who moved its adoption. The motion was seconded by Vice Mayor Cabrera and upon being put to a vote, the vote was as follows:
