## **RESOLUTION No. 17-214**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, RETROACTIVELY APPROVING THE EMERGENCY REINSTALLATION OF SHADE CANOPIES AT PARKS BY REGAL CONTRACTORS, INC. IN AN AMOUNT NOT TO EXCEED \$18,630.00 PLUS A 10% CONTINGENCY FOR A TOTAL NOT TO EXCEED AMOUNT OF \$20,493.00; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, On September 5, 2017, the City of Doral (the "City") began its hurricane preparation in anticipation of the impact from Hurricane Irma, which included, in part, the removal of all of the shade canopies from its facilities by the Parks Department to ensure that the canopies were not damaged by the storm and that the infrastructure which holds the canopies were not damaged as well; and

WHEREAS, After Hurricane Irma cleared the South Florida area, and the City began its post hurricane recovery efforts, the Parks & Recreation Department began contacting vendors and working on obtaining proposals from them to reinstall the shade canopies back at park facilities. Staff obtained several proposals from vendors and found that the proposal from Regal Contractors, Inc. to be the lowest, most responsible, and responsive proposal; and

**WHEREAS,** Staff respectfully requests retroactive approval for the emergency reinstallation of shade canopies at parks by Regal Contractors, Inc. in an amount not to exceed \$18,630.00 plus a 10% contingency for a total not to exceed amount of \$20,493.00; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

**Section 1.** Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval & Authorization. The City Council hereby approves the emergency reinstallation of shade canopies at parks by Regal Contractor's Inc. in an amount not to exceed \$18,630.00 plus a 10% contingency for a total not to exceed amount of \$20,493.00.

<u>Section 3.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> This resolution shall take effect immediately upon adoption.
