

RESOLUTION No. 19-132

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, ESTABLISHING A COMPLETE COUNT COMMITTEE COMPRISED OF INDIVIDUALS FROM DIVERSE SECTORS TO WORK COLLABORATIVELY ON A CAMPAIGN TO MOBILIZE THE CITY OF DORAL'S RESIDENTS TO BE COUNTED IN THE 2020 CENSUS; PROVIDING FOR IMPLEMENTATION AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the United States Census is a decennial census mandated by Article I, Section 2 of the United States Constitution; and

WHEREAS, a census is the procedure of systematically acquiring and recording information about the members of a given population; and

WHEREAS, census data are commonly used for research, business marketing, and planning, and as a baseline for designing sample surveys by providing a sampling frame such as an address register; and

WHEREAS, census counts are necessary to adjust samples to be representative of a population by weighing them as is common in opinion polling; and

WHEREAS, stratification requires knowledge of the relative sizes of different population strata which can be derived from census enumerations; and

WHEREAS, the City of Doral resolves to form a Complete Count Committee comprised of individuals from diverse sectors to work collaboratively on a campaign to mobilize the City of Doral's residents to be counted in the 2020 Census; and

WHEREAS, the City of Doral resolves that the Complete Count Committee include individuals from the City of Doral's government; community, and faith-based organizations; the media; education; business; labor; philanthropic institutions; and other individuals that work with or are familiar with hard-to-count residents; and

WHEREAS, the City of Doral resolves that the members of the Complete Count Committee shall represent the full geographic, gender, racial, ethnic, and age diversity of the City of Doral.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Creation of the Complete Count Committee. There is hereby created an advisory committee to be known as the Complete Count Committee. The Committee shall sunset on April 2, 2020, unless extended by resolution of the City Council.

Section 3. Duties and Responsibilities. Provide Census Questionnaire Assistance Centers at the City of Doral facilities; providing facilities to make computer technology available for residents to complete their Census 2020 questionnaires.

Section 4. Support. The City administration will provide guidance and assistance to carryout marketing efforts to encourage City of Doral residents to participate in the 2020 Census.

Section 5. Transmittal. The City Clerk is hereby directed to transmit this Resolution to such individuals as deemed appropriate, to ensure that they City's position with this regard is clearly received and understood.

Section 6. Effective Date. This Resolution shall become effective immediately upon its adoption.

The foregoing Resolution was offered by Vice Mayor Mariaca who moved its adoption. The motion was seconded by Councilmember Cabral and upon being put to a vote, the vote was as follows:


