If Chair Watts cannot be present, Secretary Flynn plans on speaking before the Commission, and Member Bautista will present VFW information specifically. Commission Meeting will be April 13th, 10:00 a.m. Request the Board members arrive by 9:45 a.m.

For the Memorial Day Event, Advisory Board interested in having a local student play Taps, a bugle player, or trumpet player. Request to have the park open from ceremony opening to noon on Monday. The Board will need to work through the Parks Department to reach out to the schools and have the park open for specific hours. Request for the City to purchase a wreath for the event. Chair Watts is requesting media or public advertising of the event. Potential for need of light snacks, bottles of water, similar for event attendees. Secretary Flynn will research specific protocols for holding Memorial Day events to build an agenda for the ceremony.

Interest in banners continues, Chair Watts will initially reach out to the banner company and work with Ms. Santos in Public Affairs.
