

RESOLUTION NO. 11- 47

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH BERMELLO, AJAMIL & PARTNERS, INC. FOR CONSTRUCTION, ENGINEERING AND INSPECTION AND CIVIL ENGINEERING CONSTRUCTION MANAGEMENT SERVICES FOR THE N.W. 50TH STREET PARK PROJECT IN AN AMOUNT NOT TO EXCEED \$101,400.00; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the majority of the work to be completed on the 50th Street Park Project is civil in nature which involves demucking; filling; underground utilities; grading; and paving; and

WHEREAS, as it is essential to have expert staff observing and inspecting these activities, Staff recommends to have Bermello, Ajamil & Partners, Inc., a City of Doral pre-qualified vendor, to provide said services; and

WHEREAS, Bermello, Ajamil & Partners, Inc. have been a part of this civil project since the beginning and would be the best firm to keep the project moving forward and built within specifications; and

WHEREAS, Staff respectfully requests that the City Council authorize the City Manager to negotiate and enter into an agreement with Bermello, Ajamil & Partners, Inc. for Construction, Engineering and Inspection and Civil Engineering Construction Management Services for the N.W. 50th Street Park Project in an amount not to exceed \$101,400.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. The City Council of the City of Doral hereby authorizes the City Manager to negotiate and enter into an agreement with Bermello, Ajamil & Partners, Inc. for Construction, Engineering and Inspection and Civil Engineering Construction Management Services for the N.W. 50th Street Park Project in an amount not to exceed \$101,400.00.

Section 2. This Resolution shall become effective immediately upon adoption.
