

RESOLUTION NO. 12-83

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH GANNETT FLEMING, INC. FOR THE PROVISION OF DORAL TROLLEY INFRASTRUCTURE IMPROVEMENTS IN AN AMOUNT NOT TO EXCEED \$85,392.26; RECOGNIZING THAT GANNETT FLEMING, INC. IS A CITY OF DORAL PRE-QUALIFIED VENDOR; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Staff has collected Doral Trolley ridership data and infrastructure needs assessment identified at each stop location to make recommendations for the design, construction and installation of bus shelters, bus bench concrete pads and associated sidewalk improvements at certain locations; and

WHEREAS, Gannett Fleming, Inc., one of ten (10) City of Doral pre-qualified vendors for professional engineering services, has submitted a proposal to provide design services for Doral Trolley Infrastructure Improvements; and

WHEREAS, Staff respectfully requests that the City Council authorize the City Manager to negotiate and enter into an agreement with Gannett Fleming, Inc. for the provision of Doral Trolley infrastructure improvements in an amount not to exceed \$85,392.26.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recognizing that Gannett Fleming, Inc. is a City of Doral pre-qualified vendor, the City Council of the City of Doral hereby authorizes the City Manager to negotiate and enter into an agreement with Gannett Fleming, Inc. for the provision of Doral Trolley infrastructure improvements in an amount not to exceed \$85,392.26.

Section 2. This Resolution shall become effective immediately upon adoption.
