These events may be monthly or every 2 months and may have the format of a seminar, fair or conference. The target will be to hold the first of such events in the October/November timeframe.
- The commission will coordinate with the City the appropriate communication protocol to inform the citizens of its activities and information of interest (website, blog, Facebook page).
- The commission will coordinate STEM (Science, Technology, Engineering & Math) informational programs with local schools & organizations to promote these fields of interest among female students.

It was also agreed that all board members would bring specific proposals including topics, calendar dates and list of potential sponsors for the information events to the next meeting.
