

RESOLUTION No. 22-196

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER WITH H&J ASPHALT, INC. FOR THE PROVISION OF ROADWAY STRIPING SERVICES ALONG THE NW 107 AVENUE AND NW 74 STREET INTERSECTION IN AN AMOUNT NOT TO EXCEED \$120,318.77; RECOGNIZING THAT H&J ASPHALT, INC. IS A CITY OF DORAL PRE-QUALIFIED VENDOR; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral Public Works Department (PWD) wishes to secure a firm to provide roadway striping services for the NW 107th Avenue and NW 74th Street intersection; and

WHEREAS, on June 14, 2022, the existing contract for “Milling, Resurfacing and Miscellaneous Stormwater and Roadway Improvement” (ITB-2019-12) expired; and

WHEREAS, the PWD proceeded to fragment the all-encompassing scope of work of previous contract to its new format of three (3) “scope specific” areas of construction; and

WHEREAS, on April 21, 2022, Request for Qualification (RFQ) No. 2022-13 “Milling, Resurfacing, and Striping Construction Services” was issued and advertised on the City’s Website; and

WHEREAS, a recommendation was made by the committee to award the top four (4) ranked firms, General Asphalt Co. Inc., H&J Asphalt Inc., H&R Paving, and Weekly Asphalt Paving Inc.; establishing a Pool of Construction Firms for “Milling, Resurfacing, and Striping Construction Services”.

WHEREAS, the Miami-Dade County (MDC) Transportation Planning Organization (TPO) approached the City to identify a needed improvement that would qualify for the MDC TPO Quick Build Project Program; and

WHEREAS, after several discussions, the intersection of NW 107th Avenue and NW 74th Street was identified as the preferred location to implement pedestrian & bicycle improvements as it is a heavily traffic intersection with significant pedestrian and bicycle traffic; and

WHEREAS, the TPO developed a conceptual plan that was approved by Miami-Dade County Traffic Engineering Division, the City then developed the construction plans for the implementation of these improvements, and MDC expedited the permitting process; and

WHEREAS, the improvements consist of high emphasis crosswalk, signage, and green bike lane striping along NW 74th Street east of NW 107th Avenue; and

WHEREAS, the PWD requested a proposal from H&J Asphalt to provide roadway striping services for the NW 107th Avenue and NW 74th Street intersection; and

WHEREAS, the PWD staff and H&J Asphalt negotiated the attached proposal on a time and material basis with a not to exceed amount of \$120,318.77; and

WHEREAS, the contract between H&J Asphalt, Inc., and the City of Doral was procured through the publicly advertised Request for Qualification (RFQ) 2022-13 process to select a pool of pre-qualified Construction Services firms for “Milling, Resurfacing, and Striping Construction Services” projects; and

WHEREAS, this group of four (4) firms was approved by the City Council during the August 2022 Council meeting via Resolution No. 22-144; and

WHEREAS, city staff respectfully requests that the Mayor and the City Councilmembers approve Work Order No. 2 for H&J Asphalt Inc., a copy of which is attached hereto as Exhibit “A”, for the provision to provide roadway striping services for the NW 107th Avenue and NW 74th Street intersection in an amount not to exceed \$120,318.77; and

WHEREAS, funding for this request is available from Transportation Fund – “Construction in Progress” Account, Account Num. 101.80005.500650.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. Work Order No. 2 for roadway striping services of NW 107th Avenue and NW 74th Street intersection, in an amount not to exceed \$120,318.77, a copy of which is attached hereto as Exhibit “A”, together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney, is hereby approved.

Section 3. Authorization. The City Manager is authorized to execute the work order and expend budgeted funds on behalf of the City.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Puig-Corve who moved its adoption. The motion was seconded by Vice Mayor Cabral and upon being put to a vote, the vote was as follows:

RFQ 2022-13 Milling, Resurfacing, and Striping Construction Services

TO: H & J Asphalt, Inc.

DATE: October 5, 2022

The City of Doral authorizes the firm of H & J Asphalt, Inc. to proceed with the provision of Construction Services for the Striping of NW 107th Avenue and 74th Street Intersection as per approved plans prepared by Gannett Fleming on 3/11/2022. Where H & J Asphalt, Inc. is a pre-qualified provider of Construction Services selected in accordance with RFQ 2022-13 requirements and approved by the City Council on August 9, 2022, through Resolution 22-144. The work should be performed in accordance with the contract provisions contained in the Construction Services Agreement between H & J Asphalt, Inc. and the City of Doral dated August 9, 2022, and the attached Proposal submitted on June 2, 2022, submitted by your firm for the above referenced project.

SCOPE OF SERVICES AND SCHEDULE:

The scope of the project will be as described in the attached proposal from H & J Asphalt, Inc. submitted on June 2, 2022, as per approved plans provided, and as per approved Miami Dade County Public Works Department #2022007342. The scope includes Striping of NW 107th Avenue and 74th Street Intersection as per approved plans. The schedule requires the work to be performed within 30 calendar days from NTP. All limitations of time set forth in this Work Order are of the essence. The performance of services associated with this Work Order will be executed based on the schedule of values submitted by H & J Asphalt, Inc., with a not to exceed amount of \$120,318.77, which includes a 10% contingency amount for any unforeseen.

You are required by the Continuing Construction Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal and revoke the award.

Work Order incorporates the terms and conditions set forth in the Continuing Construction Agreement dated August 9, 2022, between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Construction Agreement, the provisions of this specific Work Order shall prevail and apply. This Work Order is not binding until the City of Doral agrees and approves this Work Order.

IN WITNESS WHEREOF, the parties hereto have executed this Agreement on the day and date first above written, in two (2) counterparts, each of which shall, without proof or accounting for the other counterpart be deemed an original Contract.
