BILL OF SALE

THIS BILL OF SALE (this "Bill of Sale") is executed as of the day of DOWNTOWN DORAL COMMUNITY DEVELOPMENT DISTRICT, a local unit of special purpose government established pursuant to Chapter 190, Florida Statutes, being situated in the City of Doral, Miami-Dade County, Florida, having an address at 5385 N. Nob Hill Road, Sunrise, Florida 33351 ("Grantor") in favor of the CITY OF DORAL, FLORIDA, a municipal corporation existing under the laws of the State of Florida, having an address at 8401 N.W. 53rd Terrace, Doral, Florida 33166 ("Grantee").

WHEREAS, in connection with that certain Downtown Doral Roadway Improvement and Public Park Area Improvement and Maintenance Agreement by and between CM Doral Development Company LLC ("<u>Developer</u>"), a Delaware limited liability company, and the City of Doral, Florida, a municipal corporation existing under the laws of the state of Florida (the "<u>City</u>"), dated June 7, 2012 (the "<u>Agreement</u>"), Developer caused CM Doral IDF Company LLC, a Delaware limited liability company ("<u>IDF</u>") and an affiliate of Developer, to acquire the improvements more specifically described on <u>Exhibit A</u> attached hereto and made a part hereof (collectively, the "<u>Improvements</u>").

WHEREAS, IDF conveyed to Grantor all of IDF's right, title and interest in and to the Assigned Property pursuant to a certain Bill of Sale dated as of the date hereof.

WHEREAS, in connection with the Agreement, Grantor desires to assign, transfer, set over and deliver to Grantee all of Grantor's right, title and interest in and to the Improvements.

NOW, THEREFORE, in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

- 1. Grantor hereby assigns, transfers, sets over and delivers to Grantee, its successors and assigns, all of Grantor's right, title and interest in and to the Improvements.
- 2. This Bill of Sale is made without warranty, representation, or guaranty by, or recourse against Grantor of any kind whatsoever, except that, Grantor hereby warrants title to the Improvements, other than with respect to the copyright rights owned by Doner Studio, LLC in the design of a statue included in the Improvements, and will defend such title against the lawful claims of all persons claiming, by, through or under Grantor but none other.
- 3. The terms and provisions of this Bill of Sale shall be binding upon and inure to the benefit of the respective parties hereto, and their respective successors and assigns.
- 4. This Bill of Sale shall be governed by the laws of the State of Florida.
