

RESOLUTION No. 19-284

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY RENAISSANCE ELEMENTARY CHARTER SCHOOL TO HOST THE “WINTER BAZAAR” TO BE HELD AT THE SCHOOL PREMISES, LOCATED AT 10651 NW 19 ST, DORAL, FL 33172 ON SATURDAY, DECEMBER 7, 2019 FROM 11:00AM-4:00PM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Renaissance Elementary Charter School (the “Applicant”) seeks approval from the City of Doral for a Special Event Permit to host the “Winter Bazaar” in the City of Doral; and

WHEREAS, staff recommends that the Mayor & City Council Members approve the proposed Special Event Permit to host the “Winter Bazaar” on Saturday, December 7, 2019 at the school premises, located at 10651 NW 19th ST, Doral, FL 33172, from 11:00 am - 4:00 pm.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Approval. The Special Event Permit for the “Winter Bazaar” is hereby approved subject to the following conditions:

1. Applicant is responsible for paying all outstanding city fees prior to the issuance of the Special Events Permit.

Section 3. Effective Date. This Resolution shall take effect immediately upon adoption.
