

**ORDINANCE #2007- 25**

**AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF DORAL, FLORIDA, CREATING A INTERNATIONAL BUSINESS AFFAIRS ADVISORY BOARD; PROVIDING FOR MEMBERSHIP; PROVIDING FOR POWERS AND DUTIES; PROVIDING PURPOSE; PROVIDING FOR SEVERABILITY, INCLUSION IN THE CODE AND AN EFFECTIVE DATE**

WHEREAS, the City Council wishes to establish an International Business Affairs Advisory Board to advise the City Council as to international opportunities and relationships that may benefit the City of Doral; and

WHEREAS, the City Council finds it in the best interests of the citizens of Doral to establish an International Business Affairs Advisory Board; now, therefore

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. That a new Section, entitled "International Business Affairs Advisory Board," of the City of Doral Code of Ordinances is hereby created to read as follows:

**International Business Affairs Advisory Board.**

- (1) The International Business Affairs Advisory Board of the City of Doral is hereby created.**
- (2) Composition; appointment and term of members: The Board shall consist of five (5) members, all of whom shall be residents of the City of Doral. Members shall be appointed by the Mayor, subject to approval of the majority of the City Council, annually. Vacancies for the unexpired terms of members shall be appointed by the Mayor and approved by the Council.**
- (3) The powers and duties of the International Business Affairs Advisory Board shall include the following:**
  - (a) Provide advice to the City Council as to the international opportunities and relationships that may benefit the City.**

- (b) Seek to assist in the establishment and maintaining of liaisons with international public and private entities.
- (c) Serve in an advisory capacity on matters pertaining to international business affairs.
- (d) Any other duties which the City Council may, in the future, request.
- (4) Selection of officers; meetings:
  - (a) The International Business Affairs Advisory Board and its committees shall select one of their members as Chairperson and such other officers as they may determine.
  - (b) The Board and its committees shall meet at such time and place as provided in their rules or procedures which rules shall also provide for the transaction of the business. Such rules and procedures shall become effective after approval by the City Council.
- (5) Membership; removal. The City Council shall have the authority to remove any member of the Board for misconduct, or for more than three (3) unexcused absences in any one (1) calendar year.

Section 2. Repeal of Conflicting Provisions. To the extent any provisions of the Code, as made applicable to the City through Section 8.03 of the City Charter conflict with this Chapter, those provisions are repealed in its entirety.

Section 3. Severability. The provisions of this Ordinance are declared to be severable and if any section, sentence, clause or phrase of this Ordinance shall for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, sentences, clauses, and phrases of this Ordinance but they shall remain in effect, it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

Section 4. Inclusion in the Code. It is the intention of the City Council, and it is hereby ordained that the provisions of this Ordinance shall become and be made a part of the Code of the City of Doral, Florida; that the sections of this Ordinance may be renumbered or relettered to accomplish such intentions; and

that the word "Ordinance" shall be changed to "Section" or other appropriate word.

Section 5. Effective Date. This Ordinance shall be effective upon adoption on second reading.

The foregoing Ordinance was offered by Councilman Van Name who moved its adoption. The motion was seconded by Vice Mayor Cabrera and upon being put to a vote, the vote was as follows:
