

**AGREEMENT BETWEEN
THE CITY OF DORAL, FLORIDA
AND
TIRESOLES OF BROWARD (MIAMI TIRESOLES)**

This Agreement ("Agreement") made up this 8th day of May 2019, by and between the City of Doral, Florida, a municipal corporation of the State of Florida ("City") and Tiresoles of Broward (Miami Tiresoles) ("Vendor") having its place of business at 1865 South Powerline Road STE C Deerfield Beach FL 33442, for the provision of Tires for the City's vehicle.

WHEREAS, pursuant to section 2-322 of the City code, staff has recommended the City enter into an agreement with the awarded authorized dealer Tiresoles of Broward (Miami Tiresoles), via State of Florida contract No.25172500-19-ACS for the purchase of Tires; and

WHEREAS, the State of Florida Department of Management Services has an approved contract for tires and services with Tiresoles of Broward authorized reseller ; and

WHEREAS, on June 8, 2019 the Mayor and the City Council members adopted Resolution No. 19-124 authorizing the City Manager to enter into an agreement with Tiresoles of Broward (Miami Tiresoles), for the purchase and delivery of Tires at reduced rates for City vehicles and equipment, based on the State of Florida Tires, Tubes, Service Contract in an amount not to exceed the departmental budgeted amount.

NOW THEREFORE, in consideration of the mutual covenants set forth in this Agreement, the parties agree as follows:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Agreement. The City of Doral and Tiresoles of Broward (Miami Tiresoles), agree on the provision of Tires for City vehicles and equipment, based on the State of Florida Tires, Tubes and Service contract No. 25172500-19-ACS. This Agreement shall expire on March 31th, 2024.

Section 3. All terms and conditions, including pricing, from the State of Florida Tires, Tubes and Services contract, State Term Contract No. 25172500-19-ACS are incorporated in this agreement.


Section 4. Contractor agrees to perform the services upon the terms and conditions set forth in the State of Florida Contract.


Section 5. Governing Law and remedies shall be amended as follows: "The validity of this agreement and any terms and provisions as well as all rights and duties of the parties here under shall be governed by the laws of the State of Florida and the venue shall be Miami-Dade County."

IN WITNESS WHEREOF, the parties hereto have executed this Agreement on the day and date for above written, in three (3) counterparts, each of which shall, without proof or accounting for the other counterpart be deemed an original.

RESOLUTION No. 19-124

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE ADOPTION OF STATE OF FLORIDA CONTRACT No. 25172500-19-ACS FOR THE PURCHASE OF TIRES, TUBES AND SERVICES IN AN AMOUNT NOT TO EXCEED ANNUAL BUDGETED FUNDS; AUTHORIZING THE CITY MANAGER TO ADOPT THE STATE OF FLORIDA CONTRACT AND TO EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (The "City") seeks to adopt a State contract for the procurement of replacement tires for the City of Doral Vehicles; and

WHEREAS, pursuant to section 2-322 of the City code, staff has recommended the City enter into an agreement with the awarded authorized dealer, via State of Florida contract No.25172500-19-ACS for the purchase of Tires, Tubes and Services; and

WHEREAS, this adoption will allow the City to benefit from the discounted rates and will ensure their availability; and

WHEREAS, cost and availability are some of the most important factors in ensuring an efficient vehicle maintenance; and

WHEREAS, the PWD respectfully requests that the City Council authorize the City Manager to adopt the State of Florida Contract No. 25172500-19-ACS which was completely bid in a similar manner to that the set forth in Chapter 2, Article V, of the City's Code of Ordinance for the purchase of Tires, Tubes and Services, and authorize the City Manager to expend budgeted funds in a not to exceed amount of the annual budgeted funds, for the period set forth in the State of Florida Contract and any approved additional subsequent extensions.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Authorization. The City Council of the City of Doral hereby authorizes the City Manager to adopt the State of Florida Contract No. 25172500-19-ACS for the purchase of Tires, Tubes and Services, as required, Pursuant to Section 2-322 of the City's Code of Ordinances, in an amount not to exceed annual budgeted funds. Funds for these purchases are budgeted in the Public Works – "Contractual Services – Fleet Maintenance" Account number 001.80005.500346.

Section 3. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Vice Mayor Mariaca who moved its adoption. The motion was seconded by Councilmember Cabral and upon being put to a vote, the vote was as follows:


