

**RESOLUTION NO. 13 -06**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA WAIVING THE COMPETITIVE BID PROCESS AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH PERCONTI DATA SYSTEMS,INC. TO UPGRADE THE CODE COMPLIANCE MODULE FROM UTOPIA TO CD-PLUS IN AN AMOUNT NOT TO EXCEED \$50,000; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, since 2007, the Code Compliance Department has had a contract with Perconti Data Systems, Inc. to provide software, consulting and development services, and

**WHEREAS**, Perconti Data Systems has been in business for almost 30 years and has clients throughout the State of Florida; and

**WHEREAS**, the City of Doral wishes to have the most up to date technology that will efficiently serve the citizens of the community; and

**WHEREAS**, Perconti Data Systems upgrade would be the CD-Plus module that is a powerful, customized community development management system; and

**WHEREAS**, the CD-Plus System contains five modules 1) Permitting and Inspections 2) Code Compliance 3) Business Tax Receipts/Occupational Licensing 4) Development Review 5) Growth Management; and

**WHEREAS**, the cost of the Module is \$50,000.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AS FOLLOWS:**

**Section 1.** Pursuant to Section 2-321 of the Doral Code of Ordinances, The Mayor and City Council hereby authorizes waiver of the competitive bidding process

and upgrade the Utopia Module being utilized by the Code Compliance Department and Planning Department to CD-Plus Module offered by Perconti Data Systems.


**Section 2.** The Mayor and City Council further authorizes the City Manager to negotiate and enter into an agreement with Perconti Data Systems for the purchase of CD – Plus, not to exceed \$50,000.


