

RESOLUTION No. 15-234

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AWARDED INVITATION TO BID 2015-34 FOR FIELD FORCE EQUIPMENT FOR THE POLICE DEPARTMENT TO FEDERAL EASTERN INTERNATIONAL, INC.; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH FEDERAL EASTERN INTERNATIONAL, INC. FOR THE PROVISION OF PURCHASING FIELD FORCE EQUIPMENT FOR THE POLICE DEPARTMENT IN AN AMOUNT NOT TO EXCEED \$34,932.50; AUTHORIZING THE CITY MANAGER TO EXPEND LAW ENFORCEMENT TRUST FUND DOLLARS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") seeks to purchase Field Force Equipment for the Police Department; and

WHEREAS, as a result, on July 22, 2015, the City issued Invitation to Bid #2015-25, Field Force Equipment for the Police Department, for which, after four hundred twenty-four notices (424) to firms were sent and two hundred ninety (290) copies of the bid downloaded, three (3) bids were received and opened on the August 26, 2015 deadline; and

WHEREAS, due to incomplete bids and high costs, the City rejected all bids for Invitation to Bid 2015-25; and

WHEREAS, on October 1, 2015, the City issued Invitation to Bid 2015-34, Field Force Equipment for the Police Department, (the "ITB"), for which, after one hundred fifty-three (153) copies of the bids were downloaded, five (5) submittals were received and opened on the October 30, 2015 deadline, with four (4) firms meeting the required criteria; and

WHEREAS, Federal Eastern International, Inc. ("Federal") was found to be the

lowest most responsible and responsive bidder; and Council

WHEREAS, staff has recommended the City award the ITB to Federal and authorize the manager to negotiate and enter into an agreement with Federal for the purchase of force field equipment, in an amount not to exceed \$34,932.50, payable from Law Enforcement Trust Fund (“LETf”) account.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Award. The ITB, for the provision of force field equipment for the police department, is hereby awarded to Federal Eastern International, Inc., pursuant to the terms specified herein. This award does not confer any contractual rights on Federal.

Section 3. Authorization. The City Manager Council is authorized to negotiate and enter into agreement with Federal Eastern International, Inc., subject to approval by the City Attorney as to form and legal sufficiency, to provide the Police Department with their Field Force Equipment, in an amount not to exceed \$34,932.50, and on such other terms and conditions as may be in the best interest of the City. The City Manager is further authorized to expend budgeted funds from LETf account 105.60005.500640 on behalf of the City with respect to the agreement approved herein.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 5. Effective Date. This Resolution shall become effective immediately upon its adoption.

The foregoing Resolution was offered by Councilmember Cabrera who moved its adoption. The motion was seconded by Councilmember Rodriguez and upon being put to a vote, the vote was as follows:
