A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, URGING THE FLORIDA LEGISLATURE TO ENACT LEGISLATION TO FURTHER REGULATE HOMEOWNERS ASSOCIATIONS AND TO SUPPORT SB56; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in 2018, the State of Florida proposed the "Homeowners' Associations", legislation prohibiting associations from hiring an attorney who represents management company of associations; and

WHEREAS, on February 13, 2019, the City of Doral passed Resolution number 19-48 urging the Florida Legislature to pass legislation enacting a review of Homeowners' Associations; and

WHEREAS, in 2019, the Florida Legislature considered HB 1075 (Rodriguez) "Community Associations", which failed on second reading; and

WHEREAS, in January of 2021, Senator Rodriguez filed SB 56 "Community Association Assessment Notices", the Senate bill requires condominium associations to maintain specified affirmative acknowledgements as official records of the Associations, revises timeframes for foreclosure judgments, requires condominium associations to deliver certain statements of account; and

WHEREAS, the City of Doral has over 150 communities which are managed by Homeowners/Condo Associations; and

WHEREAS, when HOA's do not function as planned, homeowners pay a heavy toll in court, fines, liens and foreclosures; and

WHEREAS, more oversight, government regulations, mandatory training for volunteer associations boards, background check and financial accountability need to be put in place to ensure that HOA's are managed effectively; and

WHEREAS, the City of Doral supports the passage of legislation that requires greater transparency, efficiency and accountability to Homeowners' Associations in governance and the handling of day-to-day business for the benefit of the City of Doral residents; and

WHEREAS, the City of Doral wishes to provide support for SB 56 and any legislation that further regulates Homeowner Associations.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The foregoing recitals are confirmed, adopted and incorporated herein and made a part hereof by this reference.

Section 2. Recommended Position. The Florida Legislature is hereby strongly urged to pass legislation enacting to further regulate Homeowners' Associations.

Section 3. Transmittal. The City Clerk is hereby directed to transmit this Resolution to the Speaker of the Florida House of Representatives, the President of the Florida Senate, the Governor of the State of Florida, and such individuals of Florida legislature and staff as deemed appropriate by the City Manager, to ensure that the City's position with this regard is clearly received and understood.
