## **RESOLUTION No. 17-123**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, ESTABLISHING THE PROPOSED MILLAGE RATE FOR FISCAL YEAR 2017–2018, THE CURRENT YEAR ROLLED-BACK RATE, AND THE DATE, TIME AND PLACE OF THE FIRST AND SECOND PUBLIC BUDGET HEARINGS AS REQUIRED BY LAW; DIRECTING THE CITY CLERK AND CITY MANAGER TO FILE SAID RESOLUTION WITH THE PROPERTY APPRAISER OF MIAMI-DADE COUNTY PURSUANT TO THE REQUIREMENTS OF FLORIDA STATUTES AND THE RULES AND REGULATIONS OF THE DEPARTMENT OF REVENUE AND THE STATE OF FLORIDA; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on June 30, 2017, the Honorable Pedro J. Garcia, Miami-Dade County Property Appraiser served upon the City of Doral (the "City") a "Certification of

Taxable Value" certifying to the City its 2017 taxable value; and

WHEREAS, the City Council has reviewed the taxable value supplied by the

Property Appraiser; and

WHEREAS, the provisions of Section 200.065, Florida Statutes, require that within thirty-five (35) days of service of the Certification of Taxable Value upon a municipality, said municipality shall be required to furnish to the Property Appraiser of Miami-Dade County the proposed millage rate, the current year roll back rate, and the date, time and place at which a public hearing will be held to consider the tentative millage rate and tentative budget and final millage rate and final budget; and

WHEREAS, the City Council desires to announce the dates of the first and second hearings to the Property Appraiser of Miami-Dade County; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS: **Section 1. Recitals.** The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Proposed Millage Rate. The proposed millage for the first public hearing is hereby declared to be 1.9000 mills, which is \$1.9000 per \$1,000.00 of assessed property within the City of Doral. The proposed millage is 6.23% greater than the rolled-back rate.

Section 3. <u>Rolled-Back Rate.</u> The current year rolled-back rate computed pursuant to Section 200.065 Florida Statute, is 1.7886 mills which is \$1.7886 per \$1,000.00 of assessed property within the City.

**Section 4.** Budget Hearing Dates. The dates, times and place of the first and second public hearings are hereby set as follows:

**Section 5. Effective Date.** This Resolution shall be effective immediately upon adoption.
